1. Harriet E. Kujaca died intestate, a resident of Lake County on May 4, 2001. Her husband, Ray Kujaca, died intestate, a resident of Lake County, Indiana on March 12, 2003.

3. Harriet E. Kujaca and Ray Kujaca, husband and wife, both now deceased, were the owners in fee simple of the following described real estate located in Lake County, Indiana:

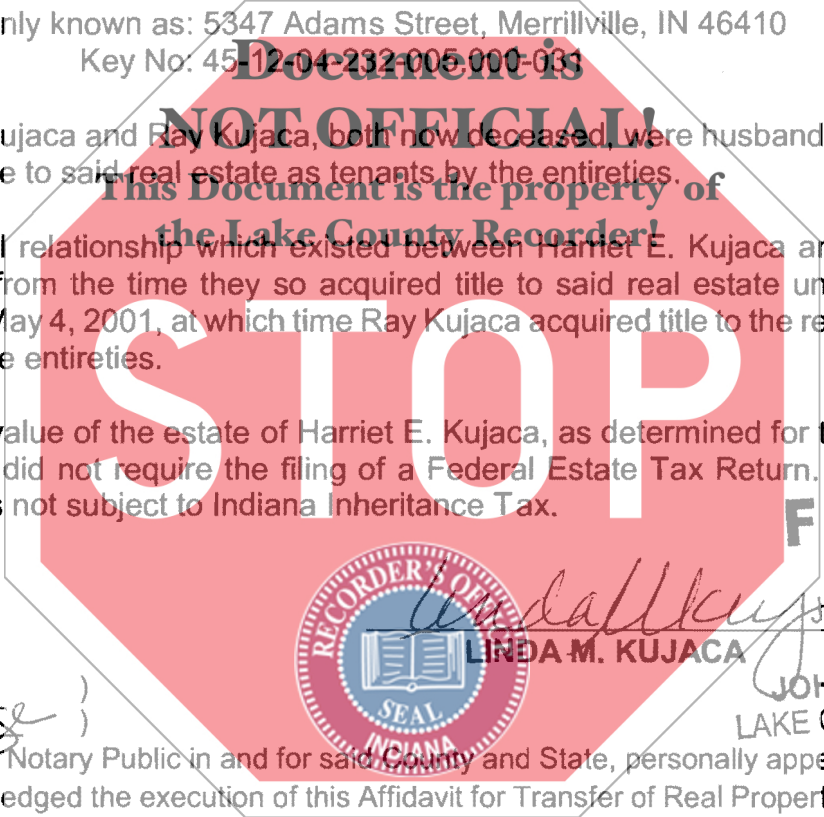
