KNOW ALL MEN BY THESE PRESENTS:

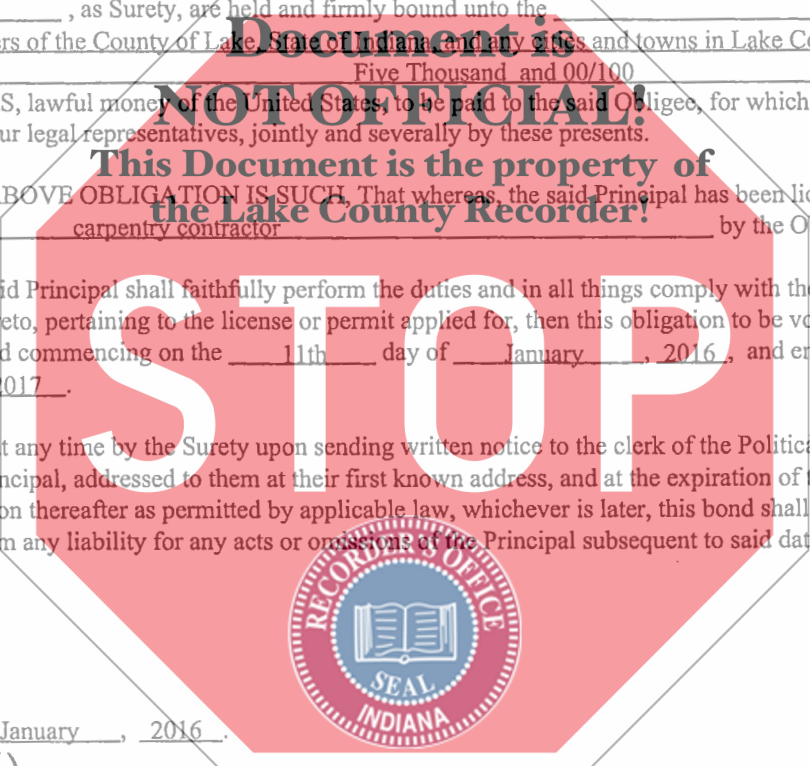
That we, F.H Acoustics Inc


