Lot A, except the West 117.67 feet thereof by parallel lines as measured along the South line thereof, in the Gates This John, Cunine Gt assubitivision picture Tokyn of St. John, Indiana recorded in Plat Book 102, page 27 in the Office of the Recorder of Lake County, Indiana.

To have and to hold the said real estate with all improvements, upon the trusts, and for the uses and purposes set forth herein and in the Trust Agreement.

Grantors, jointly and severally, by execution hereof, declare that it is their intention to elect that the real estate described herein shall be treated as matrimonial property as the same is defined in I.C. 30-4-3-35. It is our intention to have this transfer and election comply with all of the terms and conditions of I.C. 30-4-3-35, as the same exists now, or as it may exist hereafter, as the same may be amended from time to time.
