

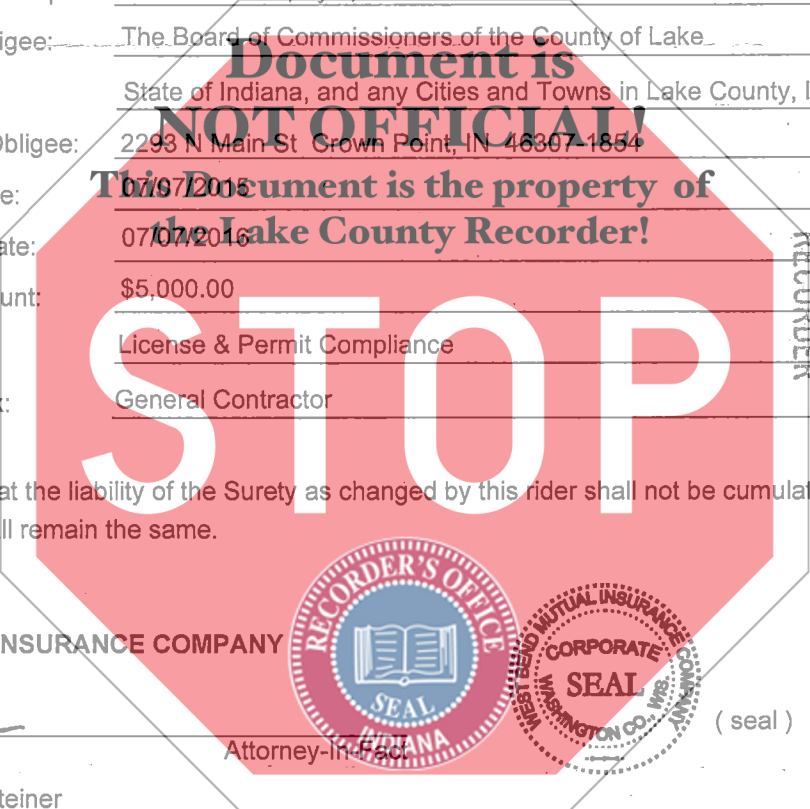

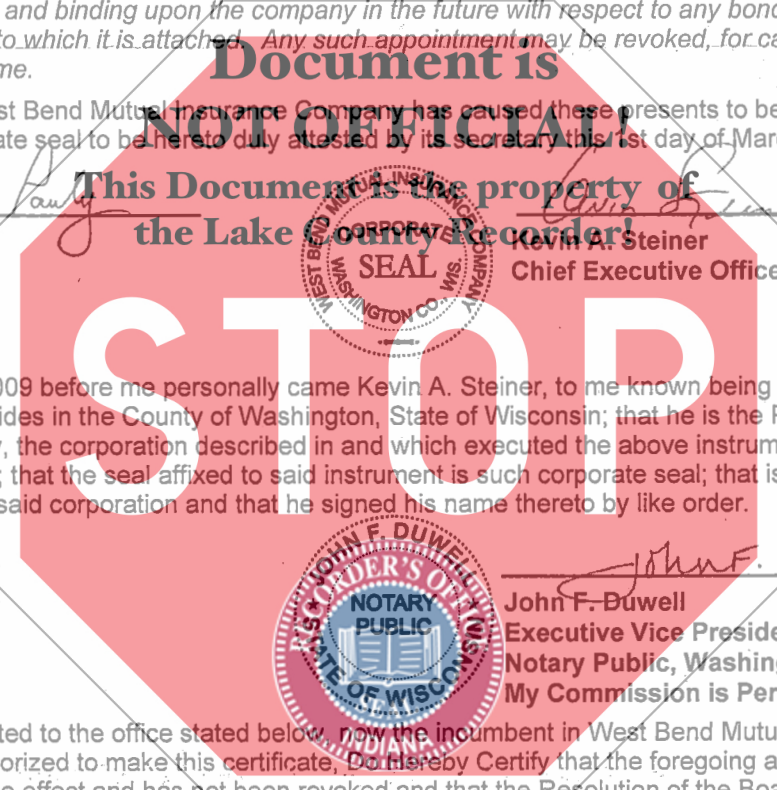
Power of Attorney

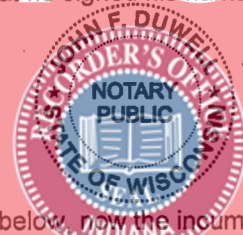
