1. The Mortgagor will promotly pay the principal of and interest of the indebtedness evidenced by the Note, and all other charges and indebtedness provided therein and in this Mortgage, at the times and in the manner provided in the Note and in this Mortgage.

2. The Mortgagor will pay when due, as hereinafter provided, all ground rents, if any, and all taxes, assessments, water rates and other governmental charges, fines and impositions, of every kind and nature whatsoever, now or hereafter imposed on the mortgaged property, or any part thereof, and will pay when due every amount of indebtedness secured by any lien to which the lien of this Mortgage is expressly subject.

3. This Mortgage and the Note were executed and delivered to secure moneys advanced, or to be advanced, by the Mortgagee as or on account of a

loan evidenced by the Note, for the purpose of making the improvements described or referred to in the Specifications dated <u>11/6/2015</u> to or on the mortgaged property, and for such other purpose, if any, described or referred to therein, which improvements are hereafter collectively called "Improvements". The Mortgagor shall make or cause to be made all the Improvements. If the construction or installation of the Improvements shall not be carried out with reasonable diligence, or shall be discontinued at any time for any reason, other than strikes, lockouts, acts of God, floods or other similar catastrophes, riots, war or insurrection, the Mortgagee after due notice to the Mortgagor is hereby authorized (a) to enter upon the mortgaged property and employ any watchmen to protect the Improvements from depredation or injury and to preserve and protect such property, (b) to carry out any or all then existing contracts between the Mortgagor and other parties for the purpose of making any of the improvements, (c) to make and enter into additional contracts and incur obligations for the purposes of completing the Improvements pursuant to the obligations of the Mortgagor hereunder, either in the name of the Mortgagee or the Mortgagor, and (d) to pay and discharge all debts, obligations and liabilities incurred by reason of any action taken by the Mortgagee, as provided on demand and shall be secured by this Mortgage; provided however, that the Mortgagee shall not be required to perform any act **socurbonizent is**

4. No building or **The Ttructure of Improvement**, fixture or personal property morphaged benchy, shall be removed or demolished without the prior written consent of the Mortgagee. The Mortgagor will not make, permit or suffer any alteration of of addition to any building or other structure or improvement now or which may hereafter be erected or installed upon the mortgaged property, or any part thereof, except the improvements required to be made pursuant to Paragraph 3 hereof, nor will the Mortgagor use, or permit or suffer the use of, any of the mortgaged property for any purpose other than the purpose or purposes for which the same is now intended to be used, without the prior written consent of the Mortgagee. The Mortgagor will maintain the mortgaged property in good condition and state of repair and will not suffer or permit any waste to any part thereof, and will prompted boots, with all the requirements of Federal, State and Local governments, or of any departments, divisions or bureaus thereof, pertaining to such property or any part thereof.

5. The Mortgagor will not voluntarily create or permit or suffer to be created or to exist, or or against the mortgaged property, or any part thereof, any lien superior to the lien of this Mortgage, exclusive of the lien or liens, if any, to which this Mortgage is expressly subject, as set forth in the granting clause above, and will keep and maintain the same free from the claims of all parties supplying labor or materials which will enter into the construction or installation of the improvements.

6. The Mortgagor will keep all buildings, other structures and improvements, including equipment, now existing or which may hereafter be erected or installed on the land mortgaged hereby, insured against loss by

fire and other hazards, casualties and contingencies, in such amounts and manner, and for such periods, all as may be required from time to time by the Mortgagee. Unless otherwise required by the Mortgagee, all such insurance shall be affected by Standard Fire and Extended Coverage Insurance policies, in amounts not less than necessary to comply with the coinsurance clause percentage of the value applicable to the location and character of the property to be covered. All such insurance shall be carried in companies approved by the Mortgagee and all policies therefore shall be in such form and shall have attached thereto loss payable clauses in favor of the Mortgagee and any other parties as shall be satisfactory to the Mortgagee. (b) In the event **the Less Counter Record the** mortgaged property the Mortgagor will give to the Mortgagee immediate notice thereof by mail, and the Mortgage may make and file proof of loss if not made otherwise promptly by or on behalf of the Mortgagor. Each insurance company issuing any such policy is hereby authorized and directed to make payment hereunder for such loss directly to the Mortgagee, instead of to the Mortgagor and the Mortgagee jointly, unless the amount of loss is payable first to the holder of a lien under a mortgage or similar instrument to which this Mortgage is expressly subject; and the insurance proceeds or any part thereof is received by the Mortgagee may be applied by the Mortgagee, at its option, either in receive of the indebtedness hereby secured, or to the restoration of the indebtedness hereby amaged. In the event of foreclosure of this Mortgage, or of any transfer of title to the mortgaged property to extinguishment of such indebtedness, all right, title and interest of the Mortgagor in and to every such insurance policy then in force, subject to the rights and interests of the holder of any such prior lien, shall pass to the grantee acquiring title to the mortgaged property together with such policy and appropriate assignment of such right, title and interest which shall be made by the Mortgagor.

7. The Improvements and all plans and specifications therefore shall comply with all applicable municipal ordinances, regulations and rules

made or promulgated by lawful authority, and upon their completion shall comply therewith.

8. Upon any failure by the Mortgagor to comply with or perform any of the terms, covenants or conditions of this Mortgage requiring the payment of any money by the Mortgagor, other than the principal amount of the loan evidenced by the Note, interest and other charges, as provided in the Note, the Mortgage may at its option make such payment. Every payment so made by the Mortgagee (including reasonable attorney's fees incurred thereby), with interest thereon from the date of such payment, at the rate of eighteen percent (18%) per annum, except any payment for which a different rate of interest is specified herein, shall be payable by the Mortgagor to the Mortgagee on demand and shall be secured by this Mortgage. This Mortgage with respect to any such amount and the interest thereon, shall constitute a lien on the mortgaged property prior to any other lien attaching or accruing subsequent to the lien of this Mortgage.

9. The Mortgagee, by any of its agents or representatives, shall have the right to inspect the mortgaged property from time to time at any reasonable hour of the day. The principal amount owing on the Note together with interest thereon and all other charges, as therein provided and all other amounts of money owing by the Mortgagor to the Mortgagee pursuant to and secured or intended to be secured by this Mortgage, shall immediately become due and payable without notice or demand upon the appointment of a receiver or liquidator, whether voluntary or involuntary, for the Mortgagor or any of the property of the Mortgagor, on boot the filing of a petition by or against the Mortgagor under the provisions of any State insolvency law or under the provisions of any Federal Bankeiptcy Act or Code, as amended, or upon the making by the Mortgagor of an assignment for the benefit of the Mortgagor's creditors. The Mortgager is authorized to declare, at its option, all or any part of such depletedness inmediately due and payable upon the happening of any of the following events:

(b) Nonperformance by the Mortgagor of any covenant, agreement, term or condition of this Mortgage, or of the Note (except as otherwise

provided in subdivision (a) hereof) or of any other agreement heretofore, herewith or hereafter made by the Mortgagor with the Mortgagee in connection with such indebtedness;

(c) Failure of the Mortgagor to perform any covenant, agreement, term of condition in any instrument creating a lien upon the mortgaged property or any part thereof, which shall have priority over the lien of this Mortgage;

(d) The Mortgagee's discovery of the Mortgagor's failure in any application of the Mortgagor to the Mortgagee to disclose any fact deemed by the Mortgagee to be material, or of the making therein or in any of the agreements entered into by the Mortgagor with the Mortgagee (including, but not limited to, the Note and this Mortgage) of any misrepresentation by, on behalf of or for the benefit of the Mortgagor;

(e) The sale, lease or other transfer of any kind or nature of the mortgaged property, or any part thereof, without the prior written consent of the Mortgagee;

12. (a) After the happening of any default hereunder, the Mortgagor shall upon demand of the Mortgagee surrender possession of the mortgaged property to the Mortgagee and the Mortgagee may enter such property and let the same and collect all the rents there from which are due or to become due, and apply the same after payment of all charges and expenses, on account of the indebtedness hereby secured and all such rents and all leases existing at the time of such default are hereby assigned to the Mortgagee as further security for the payment of the indebtedness secured hereby; and the Mortgagee may also dispossess, by the usual summary proceedings, any tenant defaulting in the payment of any rent to the Mortgagee.

The Mortgagor, within ten (10) days upon request in person or within twenty (20) days upon request by mail, will furnish promptly a written statement in form satisfactory to the Mortgagee, signed by the Mortgagor and duly acknowledged, of the amount then owing on the Note and other indebtedness secured by this Mortgage, and whether any offsets or defenses exist against such indebtedness or any part thereof. 15. The Mortgagor will give immediate notice by registered or certified mail to the Mortgagee of any fire, damage or other casualty affecting the mortgaged property, or of any conveyance, transfer or change in ownership of such property or any part thereof.

(B) the CITY with or without entry, personally or by attorney, may in its discretion, proceed to protect and enforce its rights by suit or suits in equity of Tat hav whether for damages or for the specific performance of any covenant or agreement contained in the MORTGAGE or in aid of the execution of the proceed of any other appropriate legal or hereunder, or for the enforcement of any other appropriate legal or remedy, as the CITY shall deem most effectual to protect and enforce any of its rights or duties hereunder; provided, however, that all costs incurred by the CITY under this Article shall be paid to the CITY by the OWNER on demand; and;

(C) the CITY in its discretion may, with or without entry, personally or by attorney, sell, to the extent permitted by law, to the highest bidder all or any part of the Project and all right, title, interest, claim and demand therein, and the right of redemption thereof, in one lot as an entirety, or in separate lots, as the CITY may elect, and in one sale or in any number of separate sales held at one time or any number of times, which such sale of Mease shall be made at public auction at such place in the county in the Project to be sold is situated and at such time and upon such terms as may be fixed by the CITY and briefly specified in the notice of such sale or sales. Any sale by the CITY may nevertheless, at its option, be made at such other place or places, and in such other manner, as may now or hereafter be authorized by law.

Section 23.2. <u>Receipt</u> <u>Sufficient Discharge for Purchaser</u>. The receipt of the CITY or of the court officer conducting any such sale for the purchase money paid at any such sale shall be a sufficient discharge

therefore to any purchaser of the property, or any part there of, sold as aforesaid; and no such purchaser or his representatives, grantees or assigns, after paying such purchase money and receiving such receipt, shall be bound to see to the application of such purchase money upon or for the purpose of this MORTGAGE, or shall be answerable in any manner whatsoever for any loss, misapplication or non-application of any such purchase money or any part thereof, not shall any such purchaser be bound to inquire as to the necessity or expediency of any such sale.

Section 23.3. <u>Application of Proceeds of Sale</u>. The purchase money proceeds or avails of any such sale, together with any other sums which then may be held by the CITY under this MORTGAGE as part of The Project or the proceeds thereof, whether under the provisions of this Article or otherwise, shall be paid to the CITY who shall apply such funds as follows:

FIRST: To the payment of the costs and expenses of such sale, including reasonable compensation to the CITY, its agents attorneys and counsel, and the expenses of any judicial proceedings wherein the same may be made, and of all expenses, liabilities and advances made or incurred by the CITY as permitted by this MORTGAGE, except any taxes, assessments, liens, or other charges, subjection chicks property shall have been sold.

SECOND: Portie Bayment of the whole amount of the obligations.

THIRD: To the the A yake County Recorder is required to be paid by the OWNER pursuant to any provisions of the MORTGAGE.

FOURTH: To the payment of the surplus, if any, to the OWNER or its successors or assigns, upon the written request of the OWNER or to whomsoever may be lawfully entitled to receive the same upon its written request, or as any court of competent jurisdiction may direct

Section 23.4. Appointment of Becever. The OWNER further covenants that upon the happening of any cont of befault and thereafter during the continuance of such Event of Default theses the same shall have been waived as hereinbefore provided, the CHY shall be entitled as a matter of right if it shall so elect at any time to the appointment of a receiver or receivers of The Project and of a OMNE earnings, revenues, rents, issues, profits and income thereof, with such powers as the court making such appointment shall confer, which may comprise any or all of the powers which the CITY is authorized to exercise. The OWNER, if requested so to do by the CITY will consent to the appointment of any such receiver as aforesaid.

Section 23.5. <u>Remedies Cumulative</u>. No remedy herein conferred upon or reserved to the CITY is intended to be exclusive of any other remedy or remedies, and each and every such remedy shall be cumulative, and shall be in addition to every other remedy given hereunder or now or hereafter existing at law or in equity or by statute.

Section 23.6. <u>Delay or Omission Not a Waiver</u>. No delay or omission of the CITY to exercise any right or power accruing upon any event of default shall impair any such right or power, or shall be construed to be a waiver of any such event of default or any acquiescence therein; and every power and remedy given by this MORTGAGE to the CITY may be exercised from time to time and as often as may be deemed expedient to the CITY.

Section 23.7. <u>Waiver of Extension, Appraisement of Stay Laws</u>. To the extent permitted by law, the OWNER will not during the continuance of any Event of Default hereunder insist upon, or plead, or in any manner whatever claim or take any benefit or advantage of, any stay or extension law wherever enacted, now or at any time hereafter in force, which may affect the covenants and terms of performance of this MORTGAGE; nor claim take or insist upon any benefit or advantage of any law now or thereafter in force providing for the valuation or appraisement of The Project or any part thereof prior to any sale or sales thereof which may be made pursuant to any provisions herein contained, or pursuant to the decree, judgment or order of a court of competer Currections nor after any such sale or sales, claim or exercise any right under any statute heretofore or hereafter enacted by the United States of America or by any state or territory, or otherwise to redeem the property of sold or any part thereof; and the OWNER hereby expressly waives all benefits or advantage of any such law or laws and covenants of property of sold or any part thereof; and permit the execution of every power as though no such law or laws had been made or enacted

Section 23.8 <u>Remedies Subject to Provisions of Law</u>. All rights, remedies and powers provided by this Article may be exercised only to the extent that the exercise thereof does not violate any applicable provision of law in the premises, and all the provisions of this Article are intended to be subject to all appliedble mandatory provisions of law which may be controlling in the premises and to be limited to the extent necessary so that they will not preder this MORTGAGE invalid or unenforceable under the provisions of any applicable law.

Section 23.9 <u>Remedies provided for hereby or by law the CITY</u> shall have the rights of a secured party and the OWNER shall have the rights of a debtor under the Uniform Commercial Code of Indiana, codified at Indiana Code 26-1 (or any successor code or statute) with respect to the personal property included in The Project upon the occurrence and continuance of an Event of Default hereunder, as defined in Section 5.1 hereof.
