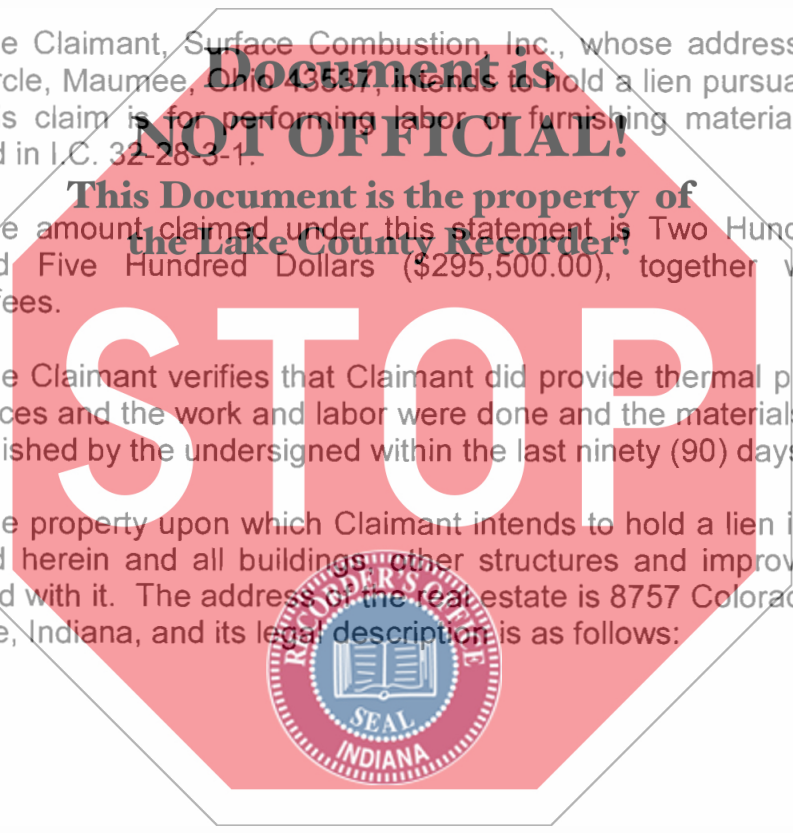
The undersigned, being first duly sworn, makes this Sworn Statement of Intention To Hold a Lien upon the real estate described below and says that:


