A trust known as the BERNICE HODAKOWSKI TRUST AGREEMENT was created by an agreement dated August 13, 1988, between BERNICE HODAKOWSKI as Trustee. Item II of that agreement provides that the Grantor may by signed instruments acknowledged and delivered to the Trustee amend that agreement from time to the Trustee amend that agreement from time to the Trustee amend that language thereof: the Lake County Recorder!

In addition thereto, the Trustee shall make payments form the principal of the Trust Estate to or for the benefit of the Grantor, in such sums and at such times as the Grantor may from time to time request. In the event that the Grantor should be unable, in the sole discretion and opinion of the Trustee, to make such request in writing, then the Trustee, in its sole discretion, may pay such amounts as deemed necessary and proper to care for, maintain and support the Grantor for so long as she shall live.
- 2. Upon the death of the Grantor, the Trustee shall use and apply so much of the Trust Property as is required for the payment of expenses incidental to

last illness and death, outstanding debts, expenses of administration of the Grantor's Estate and any estate The Trustee may pay any or all of or death taxes. such amounts to the Grantor's Executor Administrator without being required to see to the application of any amount so paid and without being under obligation to inquire as to the validity or amount of any debt, expense or tax.

After the death of the Grantor, and after the provisions of the preceding complying with paragraph as to the payment of the last expenses of the Grantor, the Trustee shall pay the following

specific bequests from the trust proceeds:

To the Carmelite Fathers of Munster, the celebration of Indiana, for the purpose of Gregorian Masses for the repose of my soul, the sum of One Thousand (\$1,000.00) Dollars;

d. To the Salvatorian Fathers Monastery of Hundred Merrillville, Indiana, the sum of Five (\$500.00) Dollars;

After satisfying the above-mentioned specific bequests and paying those Rest expenses of the Grantor as listed in Item III () of this Trust Agreement, the Trustee shall then terminate the trust and distribute any and all net proceeds, including principal and interest remaining, as follows:

daughter of the Grantor, per stirpes; and MARY CUSIC,

One-half (1/2) to JOSEPH HODAKOWSKI, son

of the Grantor, per stirpes.

In the event either MARY S. CUSIC or JOSEPH HODAKOWSKI dies without issue living at the time of distribution, such share shall pass to the survivor or to the survivor's issue by right of representation.

With the exception of Item III, the Grantor expressly hereby publishes and confirms all other parts of the original Trust Agreement dated August 13, 1988.
