The authorization is limited strictly to these purposes and any assignment to any other entity shall be void *ab ignitio*. Trustee further grants to Westcor as its attorney-in-fact full authority to act in any manner both proper and necessary to exercise the foregoing powers, and ratifies every act that Westcor may lawfully perform in exercising those powers by virtue thereof.
