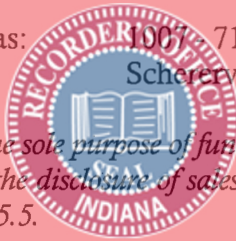

A. That at the time of the delivery thereof the trust created by this indenture and by said trust agreement was in full force and effect;

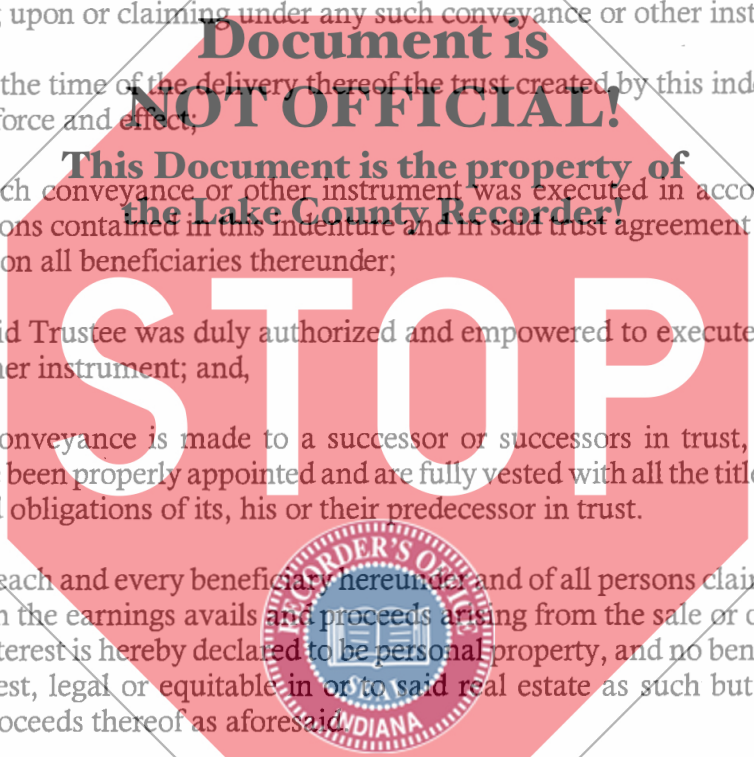
