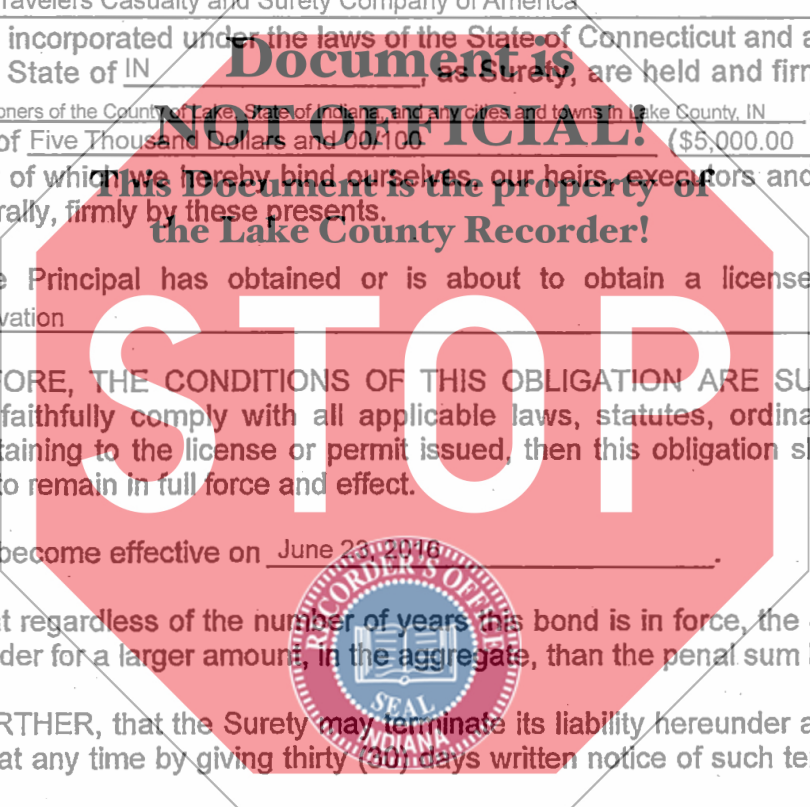

be liable hereunder for a larger amount, in the aggregate, than the penal sum listed above.


PROVIDED FURTHER, that the Surety may terminate its liability hereunder as to future acts

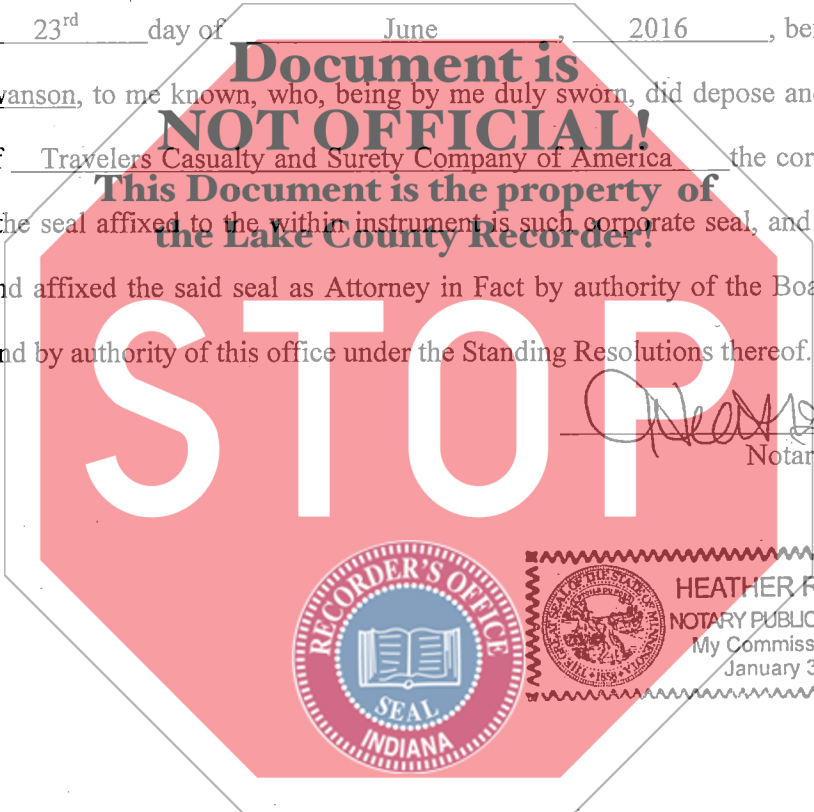

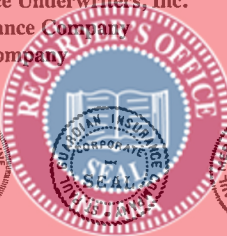
