executors, administrators, successors and assigns, jointly and severally, firmly by these presents.

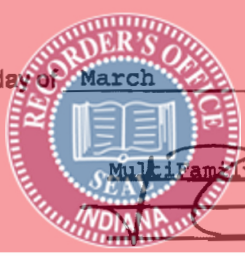
Whereas, the above bounden Principal has been granted a

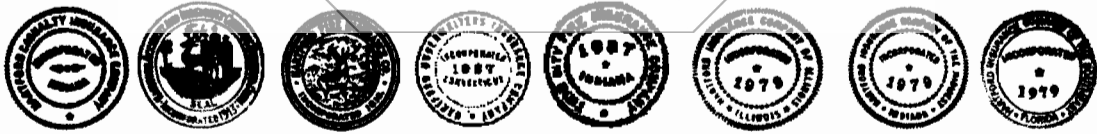


