SROKA, Husband and Wife, for and in consideration of the Sum of Ten (\$10.00) Dollars, and other good and valuable consideration, the receipt of which is hereby acknowledged, convey and warrant to GRANTEES, THOMAS SROKA and VICTORIA A. SROKA AS CO-TRUSTEES, under the provisions of that certain Trust Agreement dated December 19, 2002, and known as The Thomas and Victoria A. Sroka Trust, the following described parcel of real estate in Munster, Lake County, Indiana, to-wit:

This conveyance is made upon the express understanding and condition that neither THOMAS SROKA and VICTORA A. SROKA, as Co-Trustees, the entire legal and equitable title in fee simple, in and to all of the real estate above described.
