AMENDMENT TO REAL ESTATE MORTGAGE

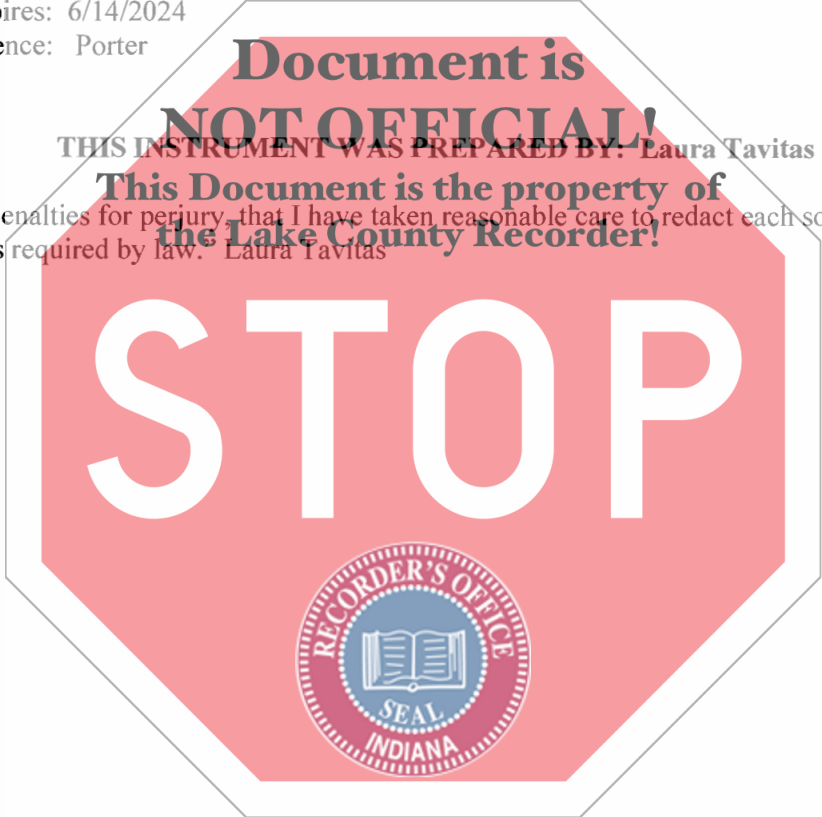
