**POWER OF ATTORNEY**

I declare that any act or thing lawfully done under this power by my attorney shall be binding on myself and my heirs, successors, assigns, and personal representatives, whether the act or thing shall have been done before or after my death, or other revocation of this instrument, unless and until actual notice of my death shall have been received by any person acting in reliance on this power. This power of attorney may be filed of record in any public office.
