THIS INDENTURE WITNESSETH, that the Grantor, Brenda L. Franklin, of Crown Point, Indiana, who hereafter reserves a life estate unto herself, for and in consideration of the sum of Ten (\$10.00) Dollars, and other good and valuable consideration, the receipt of which is hereby acknowledged, conveys and warrants to Brenda L. Franklin and Courtney Franklin, as Trustees, under the provisions of the Franklin Living Trust dated July 13, 2016, the following described real estate in Lake County, Indiana to-wit end 15.

Parcel "A" (10230 Florida Lane) Being a Part of Lot 46, Summertree Phase 1, an addition to the City of Crown Point, Lake County, Indiana, as per plat thereof, recorded in plat book 99, page 48 in the office of the recorder of Lake County, Indiana, described as: Beginning at the southeast corner of said lot; thence North 77'00'00" West, a distance of 103.93 feet to a point on a care of the westerly line of said lot, also being east right of way line of Florida lane; thence northeasterly along said curve being concave to east and having a radius of 164.50 feet, an arc distance of 68.27 feet; thence south 62'06'14" east, a distance of 118.40 feet to the easterly line of said lot; thence south 50'00'00" west along said easterly line a distance of 23.65 feet; thence south 00'22'53" east along said easterly line, a distance of 18.83 feet to the point of beginning.

contract to sell, to grant options to purchase, to sell on any terms, to convey either with or without consideration, to convey the real estate or any part thereof to a successor or successors in trust and to grant to the successor or successors in trust all of the title, estate, powers and authorities vested in the Trustee, to donate, to dedicate, to mortgage, pledge or otherwise encumber the real estate, or any part thereof, to lease the real estate, or any part thereof, from time to time, in possession or reversion, by leases to commence in praesenti or in futureo, and upon any terms and for any period or periods of time, not exceeding in the case of any single demise, the term of 198 years, and to renew or extend leases upon any terms and for any period or periods of time and to amend, change or modify leases and the terms and provisions thereof at any time or times hereafter, to contract to make leases and to grant options to renew leases and options to purchase the whole or any part of the reversion, to contract respecting the manner of fixing the amount of present or future rentals, to partition or to exchange the real estate, or any part thereof, for other real or personal property, to grant easements or charges of any kind, to release, convey or assign any right, title or interest in or about or easement appurtenant to the real estate or any part thereof, and to deal with the real estate and every part thereof in all other ways and for such other considerations as it would be lawful for any person owning the same to deal with the same, whether similar to or different from the ways above specified, at any time or times hereafter. fully vested with all the title, estate, rights, powers, authorities, duties and obligations of its, his or their predecessor in trust.

This conveyance is made upon the express understanding and condition that Brenda L. Franklin, individually, or as Trustee, nor his/her successor or successors in trust shall incur any personal liability or be subjected to any claim, judgment or decree for anything they or their agents or attorneys may do or omit to do in or about the real estate or under the provisions of this Deed or the Trust Agreement or any amendment thereto, or for injury to person or property happening in or about the real estate, any and all such liability being hereby expressly waived and released. Any contract obligation or indebtedness incurred or entered into by the Trustee in connection with the real estate may be entered into in the name of the then beneficiaries under the Trust Agreement as their attorney-in-fact, hereby irrevocably appointed for such purposes, or at the election of the Trustee, in his/her own name, as Trustee of an express trust and not individually (and the Trustee shall have no obligation whatsoever, with respect to any such contract, obligation or indebtedness, except only so far as the Trust Property and funds in the actual possession of the Trustee shall be applicable for the payment and discharge thereof). All persons and corporations whomselve and whatsoever shall be charged with notice of this condition from the date of the filing for record of this Deed.

The interestrof each and every beneficiary hereunder and under the Trust Agreement and of all persons claiming under them or any of them shall be only in the earnings, avails and proceeds arising from the sale or any other disposition of the real estate, and such interest is hereby declared to be personal property, and no beneficiary hereunder shall have any title or interest, legal or equitable, in or to the real estate as such, but only an interest in the earnings, avails and proceeds thereof as aforesaid, the intention hereof being to vest in Brenda L. Franklin, as Trustee, the entire legal and equitable title in fee simple, in and to all of the real estate above described.

In the event BRENDA L. FRANKLIN and COURTNEY FRANKLIN, Trustees, jointly or severally, are unable or refuses to act as Trusteen for any reason, then Staci Holt shall serve as Successor Trustee, as provided in the Franklin Willing Trust dated July 13, 2016.
