

Part of Block No. 26, as marked and laid down on the recorded plat of George and William Earle's Resubdivision of Blocks 21, 24, 27, 23, 28 and 26, in George and William Earle's Lake George 5th Subdivision to Hobart, also a part of 19 feet vacated by the City of Hobart under Resolution No. 429, also part of a parcel of land lying between the 19 feet vacated by the City of Hobart under Resolution No. 429 and the Northerly line of 3rd Street as now located, more particularly described as follows: Beginning at a point on the North line of said Block 26, at a point 89.57 feet East of the Northwesterly corner of said Block 26, said Northwesterly corner being 513.24 feet West of the Northeasterly corner of Block 26 by actual measurement; thence East on the North line of said Block 26, a distance of 80 feet to the Northwest corner of the tract described in Deed Record 975, page 311, in the Office of the Recorder of Lake County, Indiana; thence Southerly with an interior angle of 76°51' a distance of 63.18 feet to the Northerly line of 3rd Street, as now located; thence Westerly along the Northerly line of 3rd Street, as now located, a distance of 72 feet; thence Northerly a distance of 48.65 feet to the place of beginning, in the City of Hobart, in the Office of the Recorder of Lake County, Indiana.
