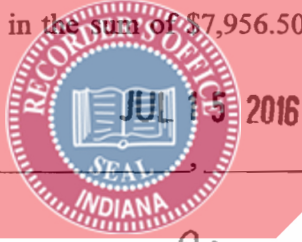
ORDER GRANTING DEFAULT JUDGMENT

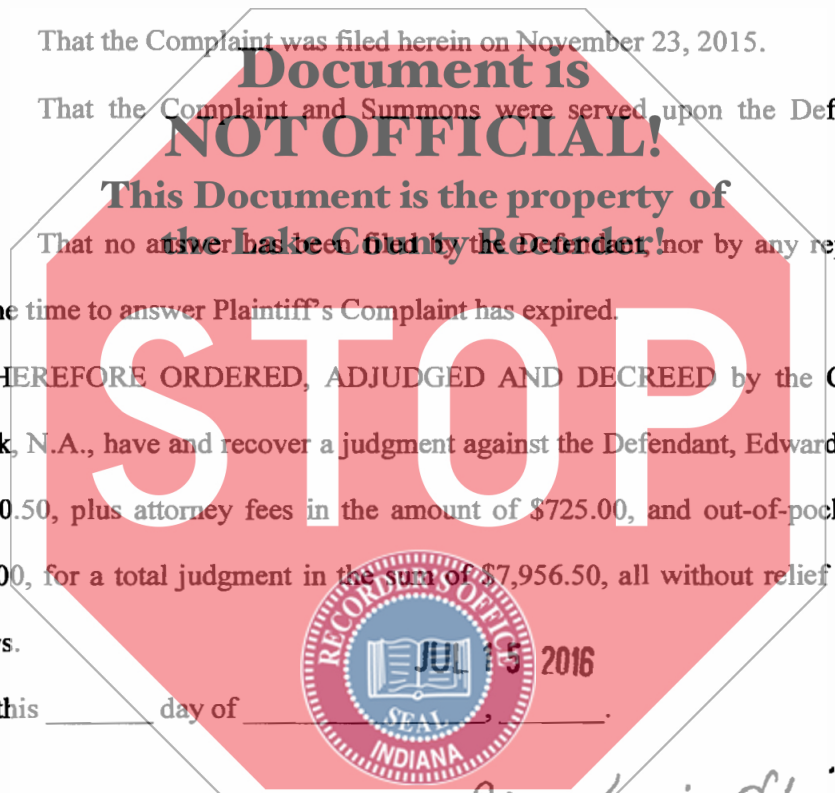
