5. This Power of Attorney shall expire on the 31st day of August, 2016.

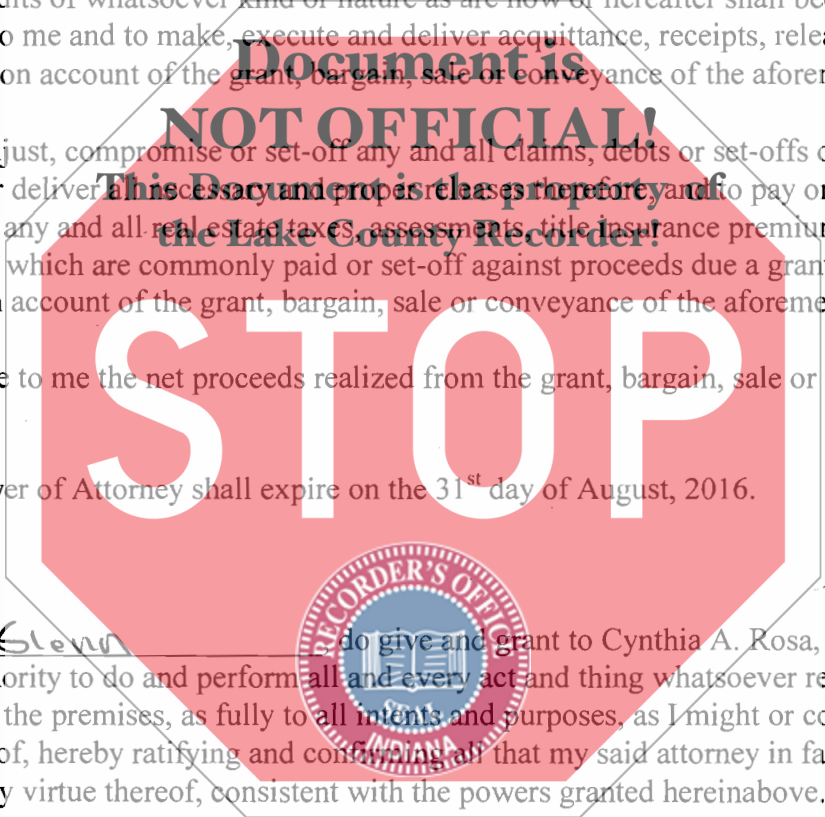

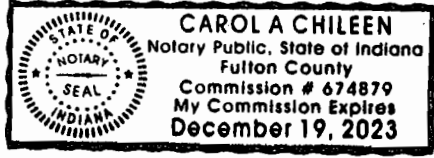

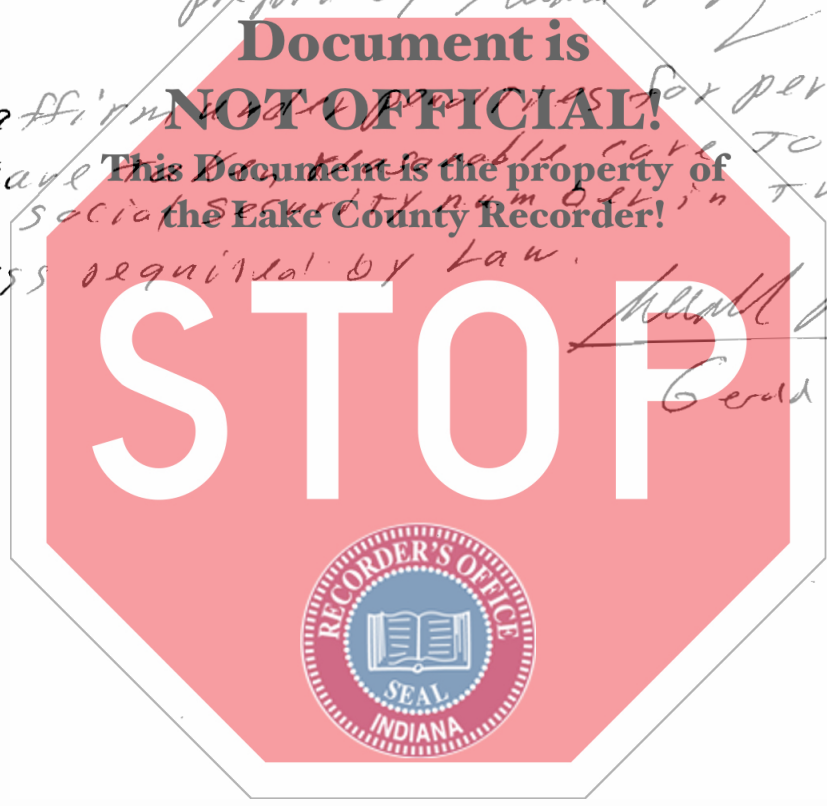
