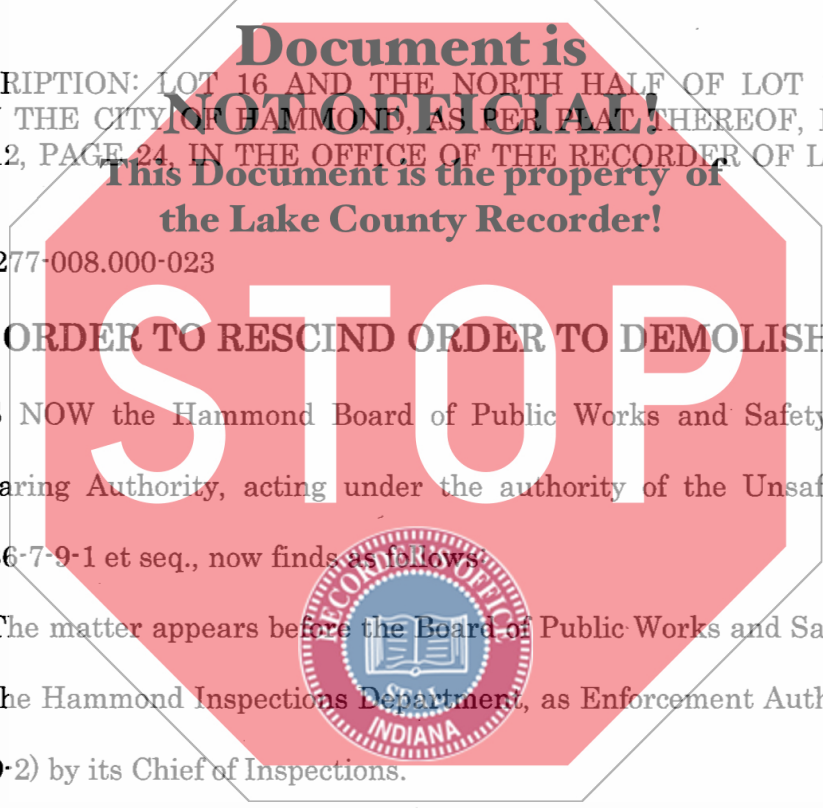

1. The matter appears before the Board of Public Works and Safety, brought by the Hammond Inspections Department, as Enforcement Authority (I.C. 36-7-9-2) by its Chief of Inspections.
2. A hearing was held on April 14, 2011 and the property was Ordered Demolished on that date and the Order to Demolish recorded on the property on April 26, 2011 as Instrument Number 2011-023556.
3. Since the Order was entered, the property has been repaired by the owner, and the Order to Demolish is no longer necessary on this property and should be rescinded.
