KNOW ALL MEN BY THESE PRESENTS:

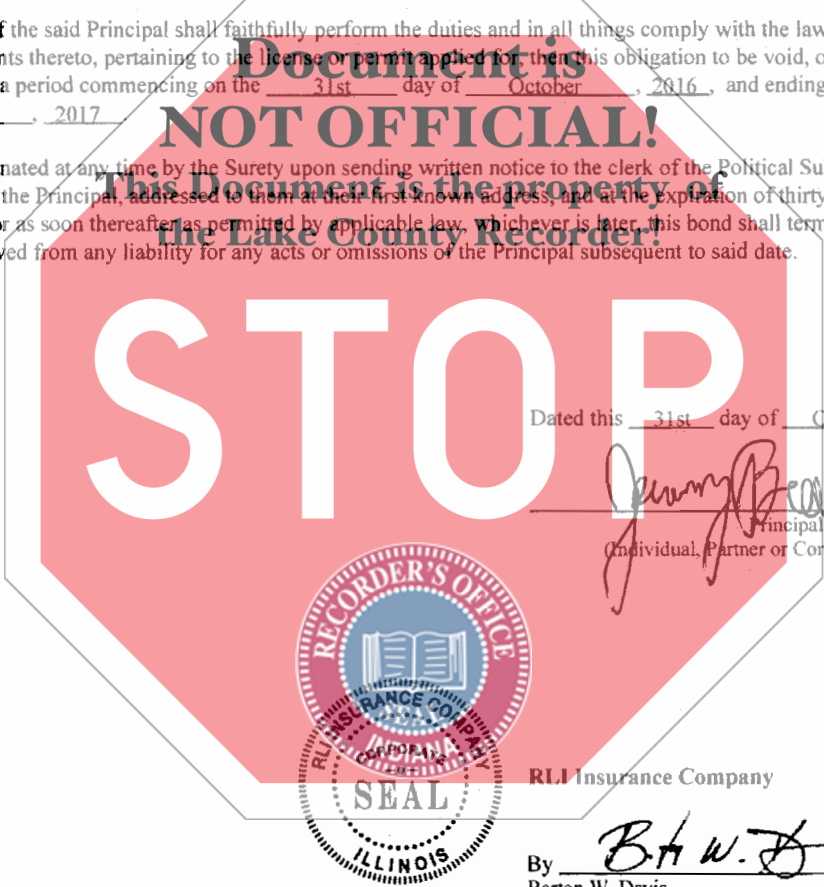
That we, Bell's Construction Exteriors, Inc.

# POWER OF ATTORNEY
