

LIMITED POWER OF ATTORNEY

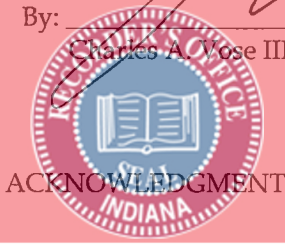



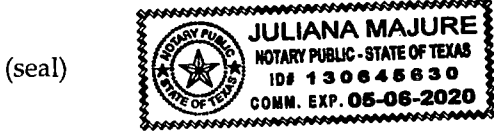
