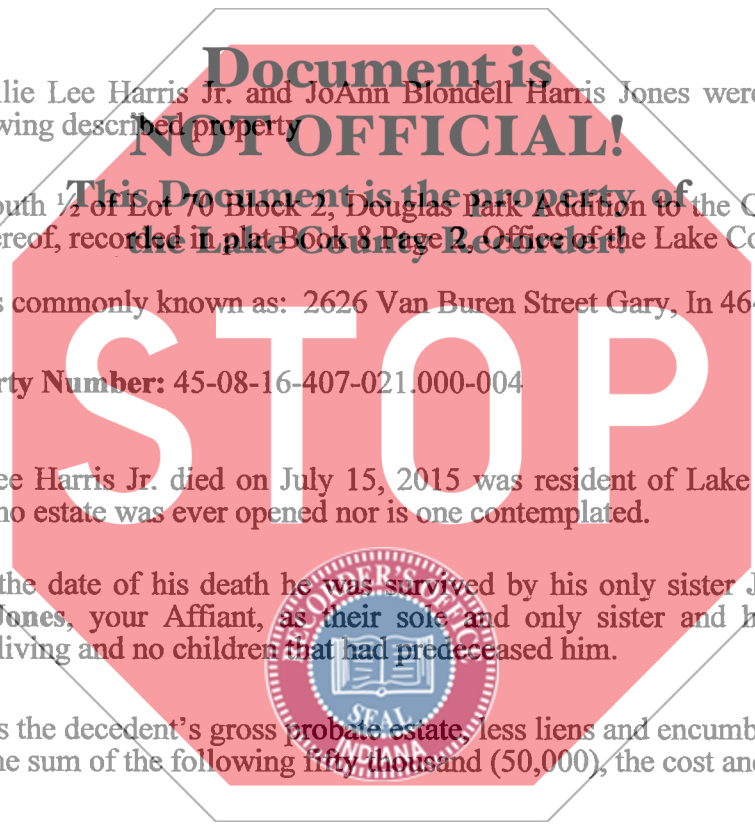
3. Willie Lee Harris Jr. died on July 15, 2015 was resident of Lake County Indiana and that no estate was ever opened nor is one contemplated.

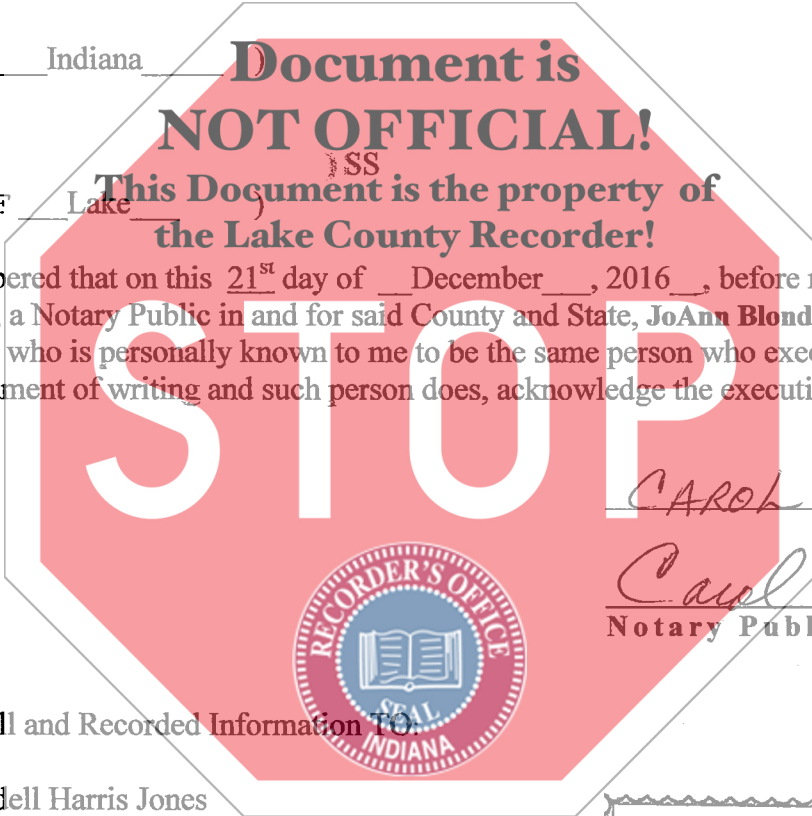
