



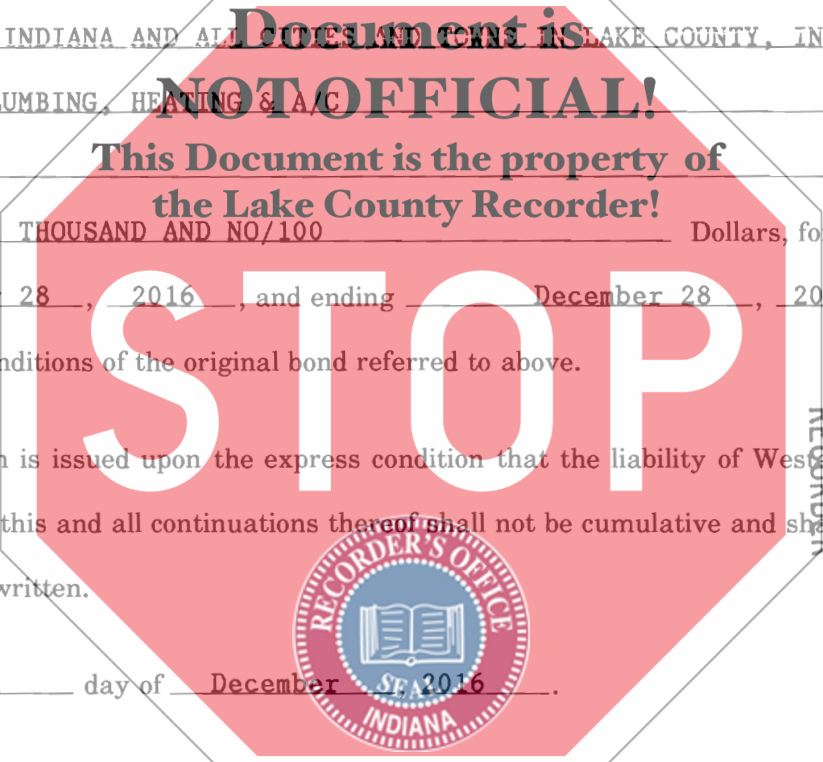

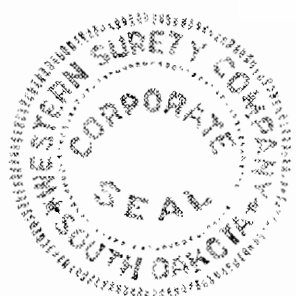

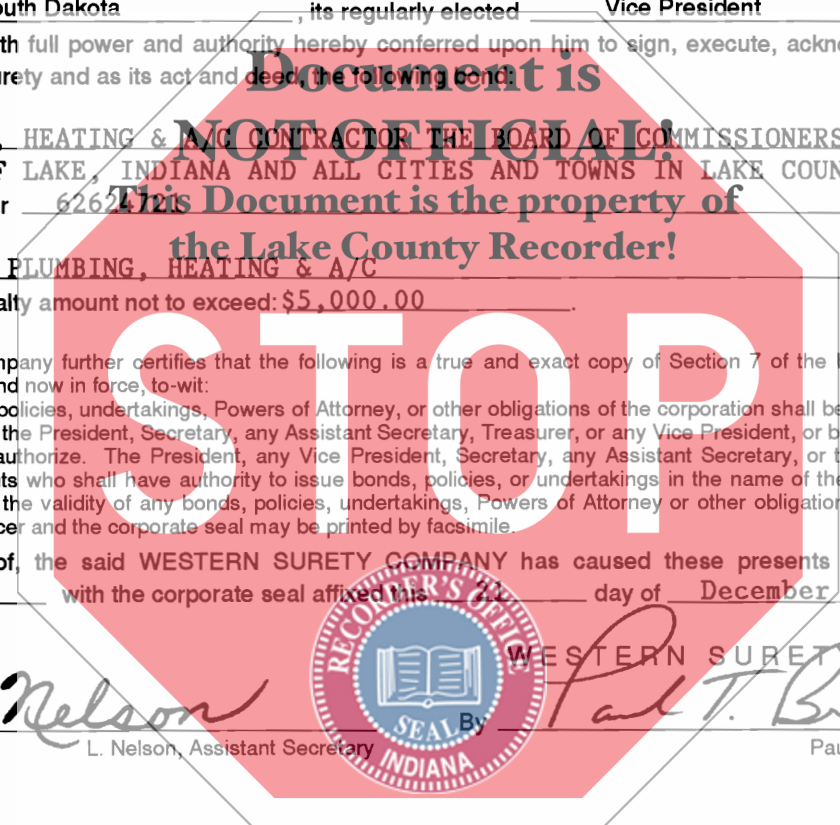
POWER OF ATTORNEY

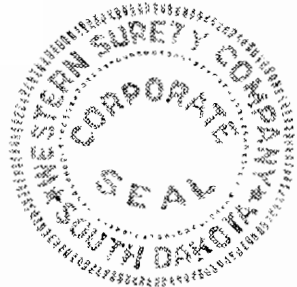

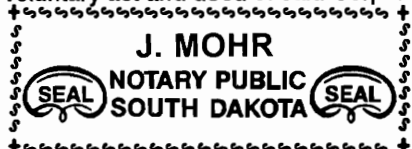
