## **EXHIBIT A**

Part of Lot 2 in Cobblestone Townhomes, Phase One, an Addition to the Town of Munster as per plat thereof recorded in Plat Book 75, page 40, as amended by Certificate of Correction Recorded February 19, 1995 as Document Number 95007702 in the Office of the Recorder of Lake County, Indiana, being more particularly described as follows:

Commencing at the Northwesterly most corner of said Lot 2; thence Northeasterly along a curve, being concave to the Northwest and having a radius of 230.00 feet, an arc distance of 31.43 feet to the Point of Beginning; thence continuing Northeasterly along said curve, an arc distance of 28.99 feet; thence South 36 degrees 40 minutes 26 seconds East, a distance of 237.28 feet to a point on the East line of said Lot 2; thence Southerly along said East line being a curve concave to the East, an arc distance of 39.96 feet; thence North 36 degrees 40 minutes 26 seconds West, a distance of 265.57 feet to the Point of Beginning all in the Town of Munster, Lake County, Indiana.
