PROVIDED, HOWEVER:

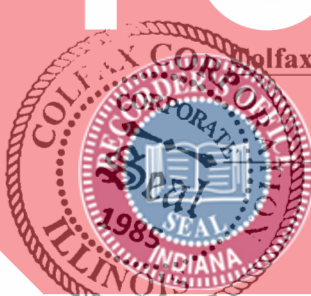
1. This bond shall continue in full force and effect Until January 12, 2018 or until the date of expiration of any Continuation Certificate executed by the Surety
