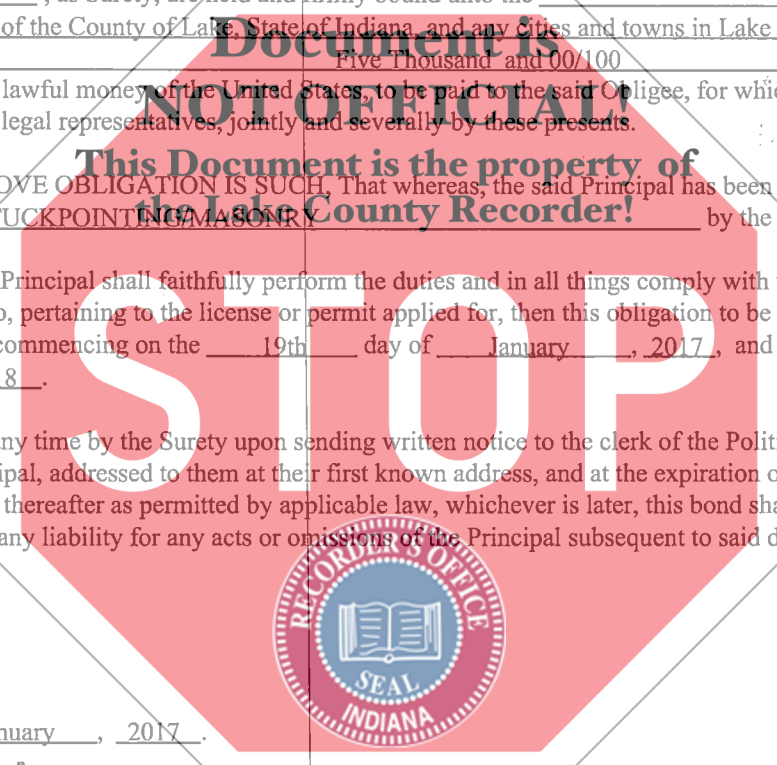

# POWER OF ATTORNEY

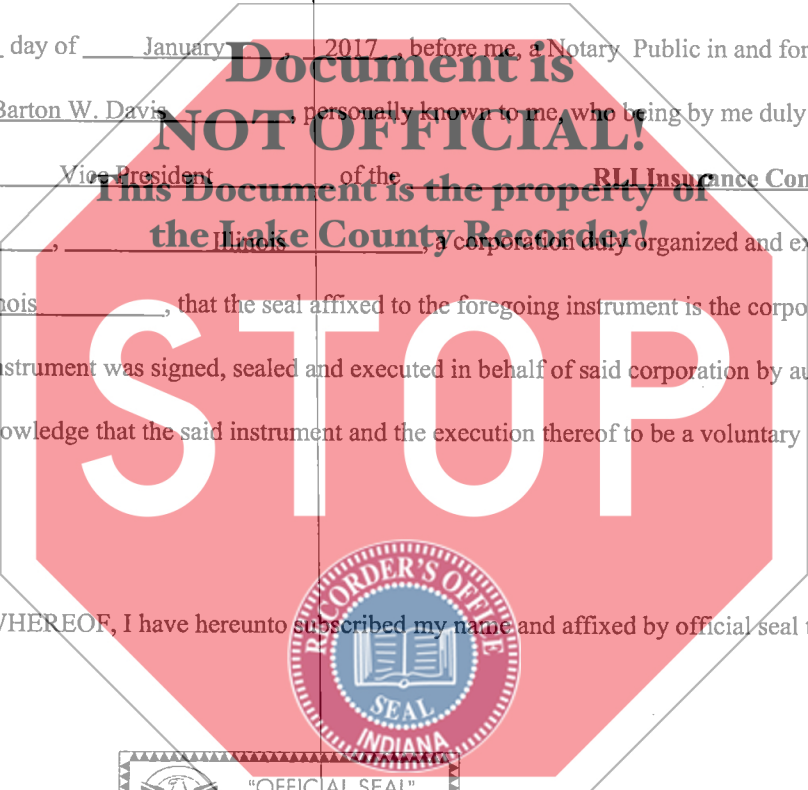
