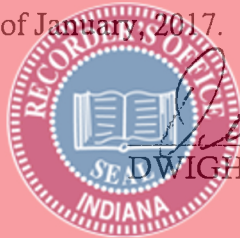
**REVOCATION AND NOTICE OF REVOCATION OF HEALTH CARE DURABLE

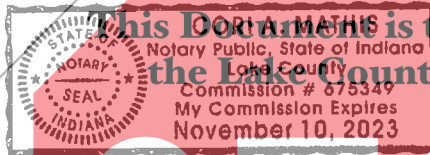
