LIMITED POWER OF ATTORNEY TO EXECUTE DOCUMENTS

5. Seller's Affidavits and Agreements;
6. Errors and Omissions Correction Agreements; and

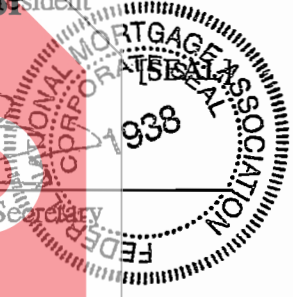

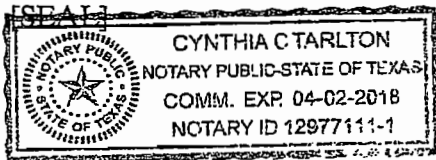
