ASSIGNMENT OF MORTGAGE

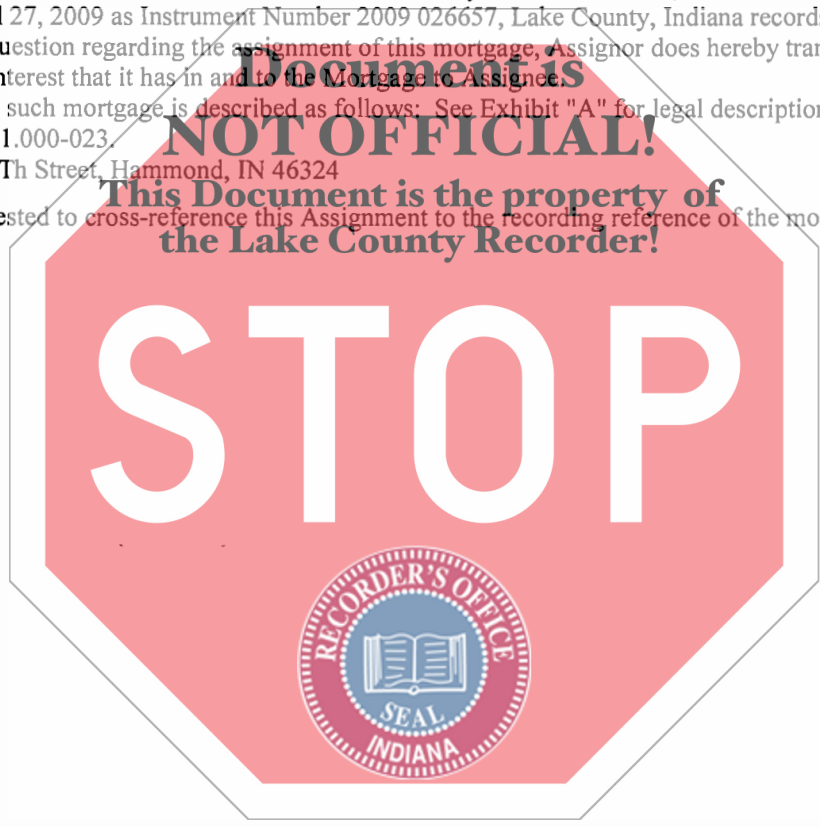

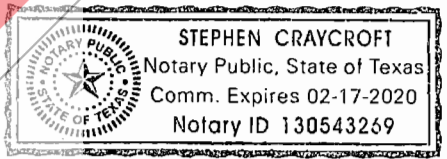
