

LIMITED POWER OF ATTORNEY

KNOW ALL PERSONS BY THESE PRESENTS that Steve McFarlane, Manager of REO Logic-Indiana Holdings, LLC, a Colorado Limited Liability Company, ("REO Logic-Indiana Holdings") does hereby make, constitute and appoint Thomas M. Reaves, David W. Campbell or James C. This Limited Power of Attorney is effective immediately and shall continue until December 31st, 2017, at 6:00 P.M. (EST), at which time it shall automatically be deemed revoked.

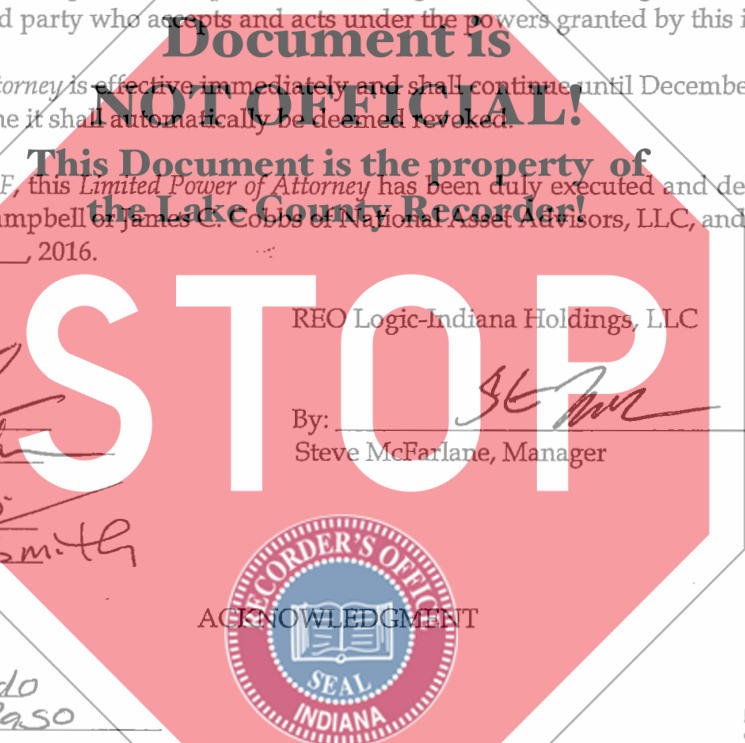
