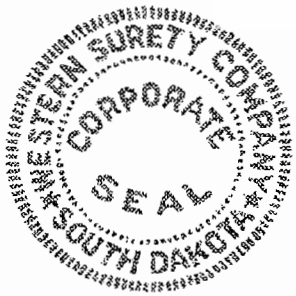

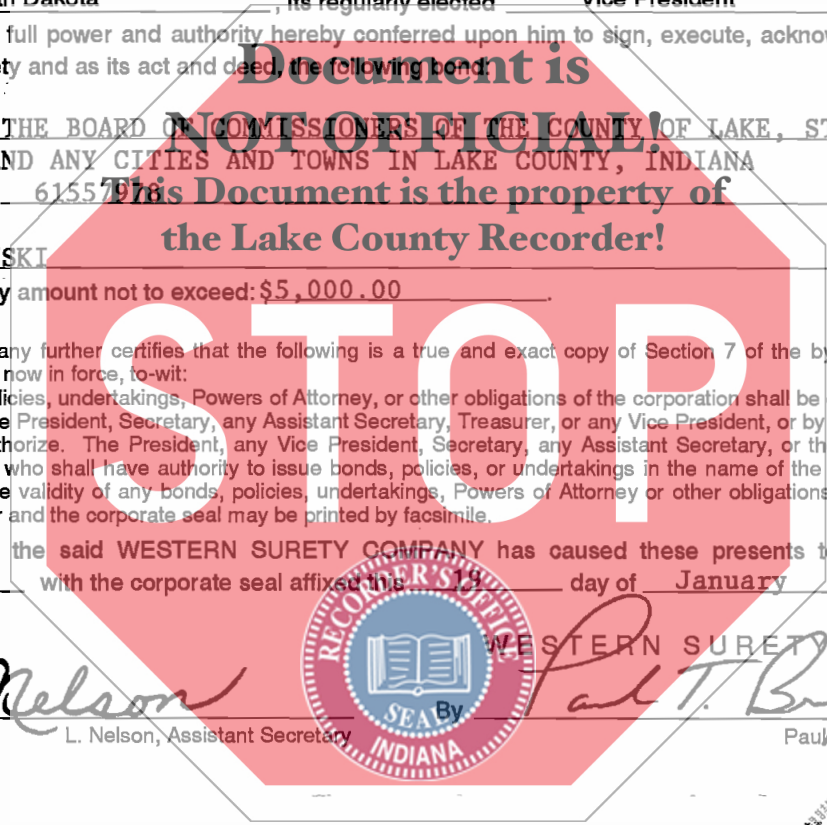
POWER OF ATTORNEY
