COMES NOW the Court, and after reviewing the written Motion for Summary

Judgment, Designation and Memorandum filed by Plaintiff and holding a hearing on

same on March 23, 2017, now finds as follows:

- 1. The above caption action commenced with a complaint to quiet title to real estate filed by Plaintiff on October 6, 2016 concerning property located at 410 Lilac, East Chicago, Indiana.
- 2. On October 25, 2016, pro se Defendant James A. DeStefano answered,

- claiming a lien against one of the named Defendants to the action and requesting that said lien serve as a bar to the entry of a quiet title order.
- 3. Plaintiff City of East Chicago on January 10, 2017 filed a Motion for Summary Judgment, Memorandum in Support of Summary Judgment and Designation of Materials in Support of Summary Judgment as to the alleged claim against 410 Lilac made by Defendant DeStefano.
- 4. James A. DeStefano did not file a response to the Motion for Summary Judgment filed by Plaintiff, nor submit any evidence in support of his claim to the property.
- 5. The balance of the Defendants in the above captioned action either disclaimed or were defaulted by the Court's Order of January 30, 2017 and title was quieted as to those Defendants.
- 6. The Court now finds that there is no genuine issue of material fact as to the matter raised in the October 25, 2016 Answer of Defendant DeStefano, in that the lien claimed by Defendant DeStefano was entered prior to the issuance of the Tax Deed to Plaintiff.
- 7. Pursuant to I.C. 6-1.1-25-4 (e), the Order of Issuance of Tax Deed entered for 410 Lilac Street, under Cause Number 45C01-1308-MI-129, recorded on the property on November 34, 2014, veets in Plaintiff, City of East Chicago, an estate in fee simple absolute, free and clear of all liens and encumbrances created or suffered before the tax sale.
- 8. Court now issues an Order quieting title as to Defendant DeStefano.
