You are hereby notified that Franciscan Health Munster, 701 Superior Ave., Munster, IN 463214029, intends to hold a Hospital Lien for all reasonable and necessary charges for hospital care, treatment, or maintenance of the above-listed patient subject to the limits and reductions of any benefits to which the patient is entitled under the terms of any contract, health plan, or medical insurance.
