KNOW ALL MEN BY THESE PRESENTS, that **Wilmington Trust Company**, a Delaware Trust Company organized and existing under the laws of the state of Delaware (the "Bank"), as the former trustee of the Trusts listed on Exhibit A hereto, hereby constitutes and appoints Ocwen Loan Servicing, LLC, (the "Servicer"), as the Bank's true and lawful Attorney-in-Fact, in the Bank's name, place and stead and for the Bank's benefit, in connection with all mortgage loans held by each of the Trusts listed on Exhibit A, solely for the purpose of performing such acts and executing such documents in the name of the Bank necessary and appropriate to effectuate the transfer of all such mortgage loans and related documents into the name of the new trustee and out of the name of the Bank and such other documents necessary or requested by the Servicer in connection with the ownership and servicing of such mortgage loans.

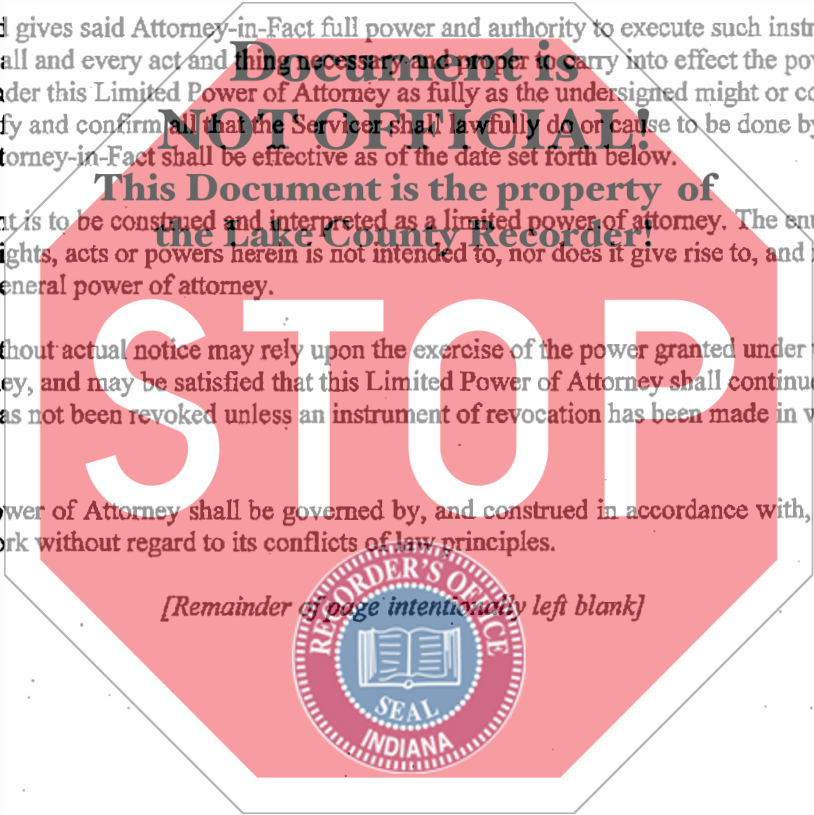

Said Attorney-in-Fact shall be effective as of the date set forth below.

This appointment is to be construed and interpreted as a limited power of attorney. The enumeration of specific items, rights, acts or powers herein is not intended to, nor does it give rise to, and it is not to be construed as a general power of attorney.

Third parties without actual notice may rely upon the exercise of the power granted under this Limited Power of Attorney, and may be satisfied that this Limited Power of Attorney shall continue in full force and effect and has not been revoked unless an instrument of revocation has been made in writing by the undersigned.

This Limited Power of Attorney shall be governed by, and construed in accordance with, the laws of the State of New York without regard to its conflicts of law principles.

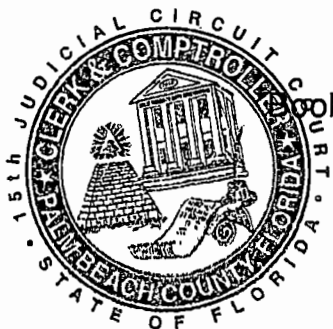
