**CERTIFICATE OF TRUST**  
**OF THE**

**DATED JANUARY 23, 2003**

I, Mary Anne Stottlemeyer, the undersigned, being first duly sworn upon my oath, state as follows:

1. I am the current acting successor trustee of the William E. Stottlemeyer Revocable Living Trust dated January 23, 2003, also known as the William Stottlemeyer Living Trust dated January 23, 2003.

2. William E. Stottlemeyer, as Grantor, on January 23, 2003, created the William E. Stottlemeyer Revocable Living Trust by executing the William E. Stottlemeyer Revocable Living Trust agreement.

3. William E. Stottlemeyer, was the initial Trustee of said trust.

4. On October 28, 2013, William E. Stottlemeyer amended the William E. Stottlemeyer Revocable Living Trust by restating it in its entirety.

5. That William E. Stottlemeyer died on January 22, 2016.

6. In Section 3.03 of Article Three of the restatement of said trust, I was designated as successor Trustee of said Trust.

7. I have accepted the appointment as successor Trustee of the William E. Stottlemeyer Revocable Living Trust.

8. The Trust was initially amendable and revocable, but after the Grantor's death, the trust became irrevocable.

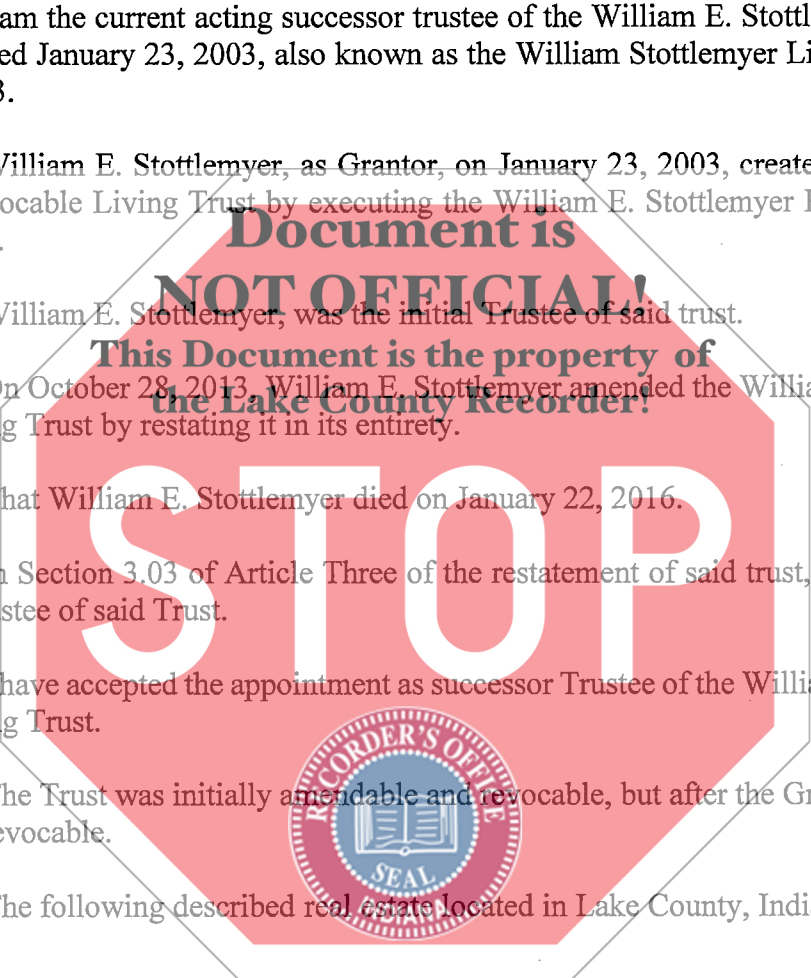
9. The following described real estate located in Lake County, Indiana is part of said restated Trust:

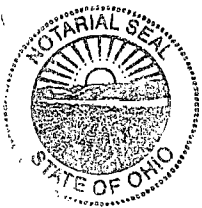
