
THE CONDITION OF THE ABOVE OBLIGATION is that the said Principal has been licensed as a(n) HVAC by the Obligees.

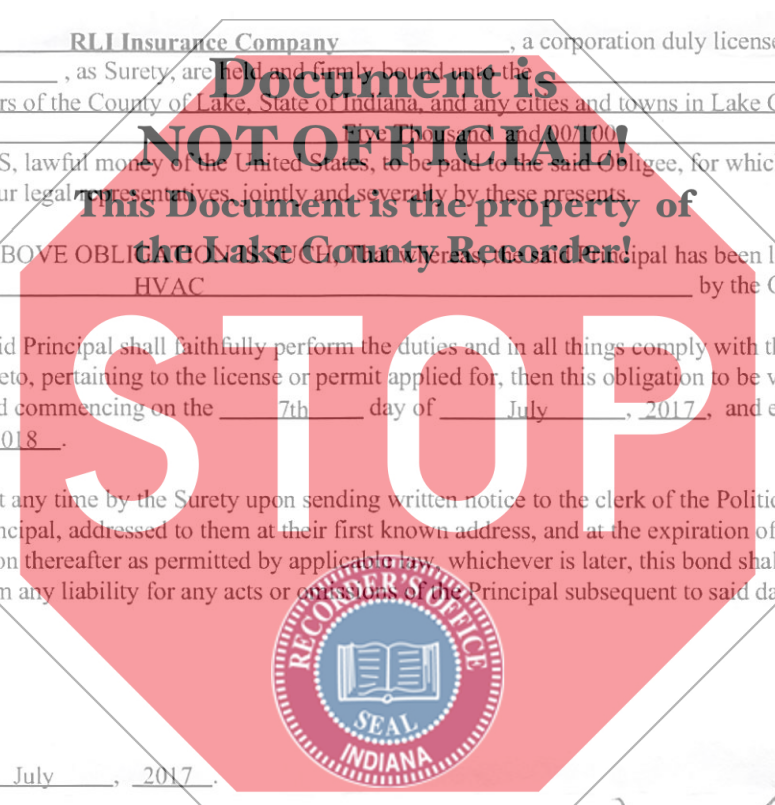

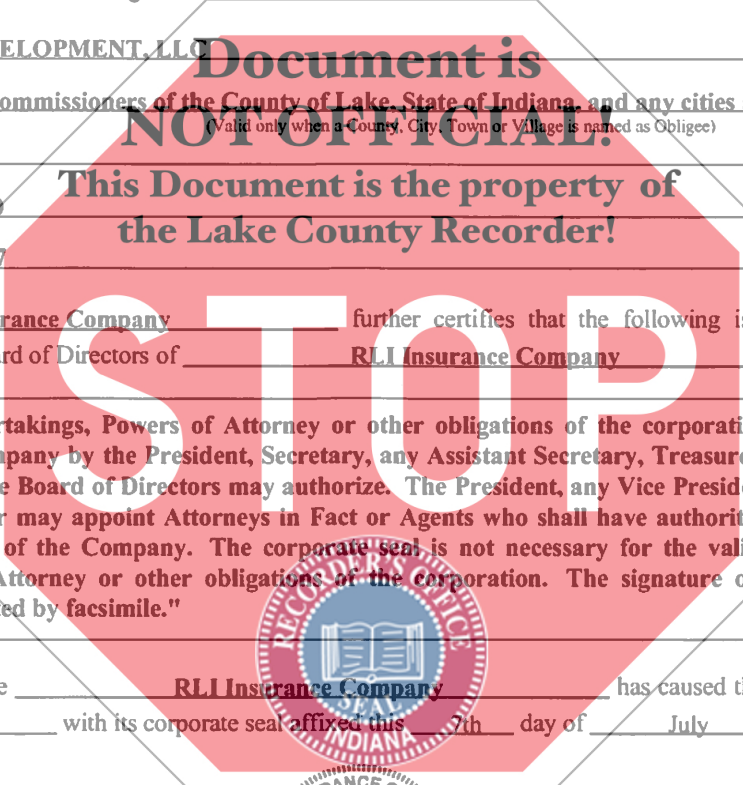
