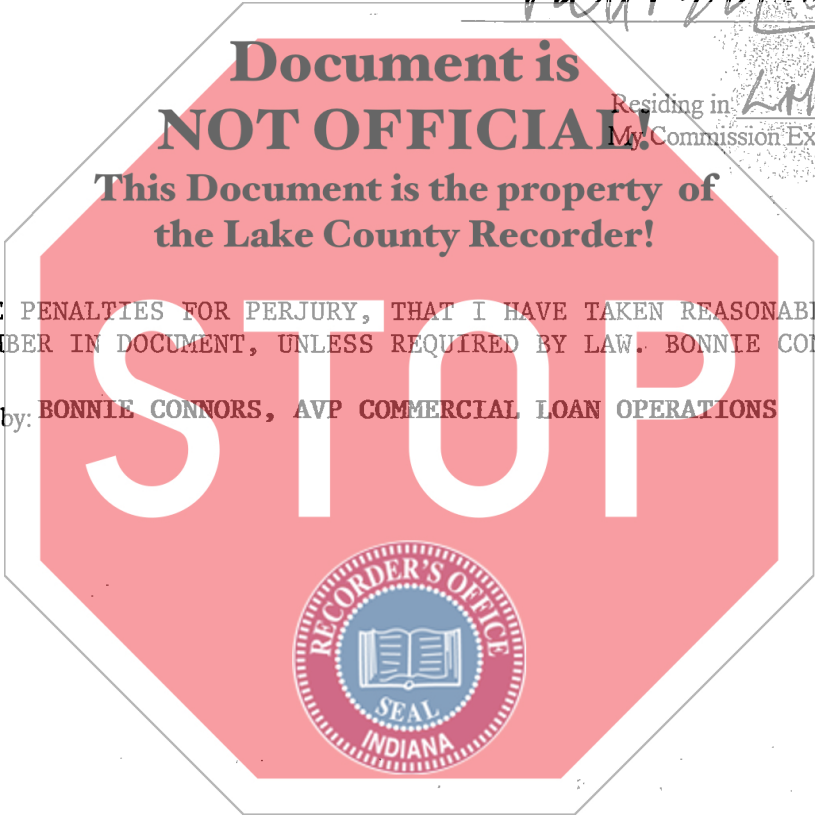




3.3. **Deletion of Mortgage Provision.** Paragraph _____ is hereby deleted from the Mortgage.
