**SWORN STATEMENT & NOTICE OF INTENTION TO HOLD HOSPITAL LIEN**

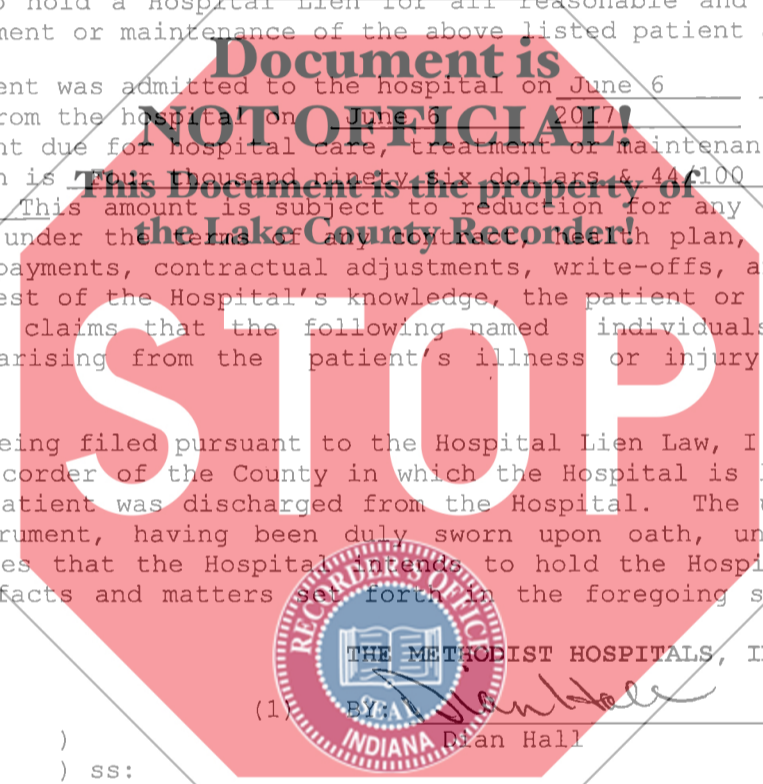
