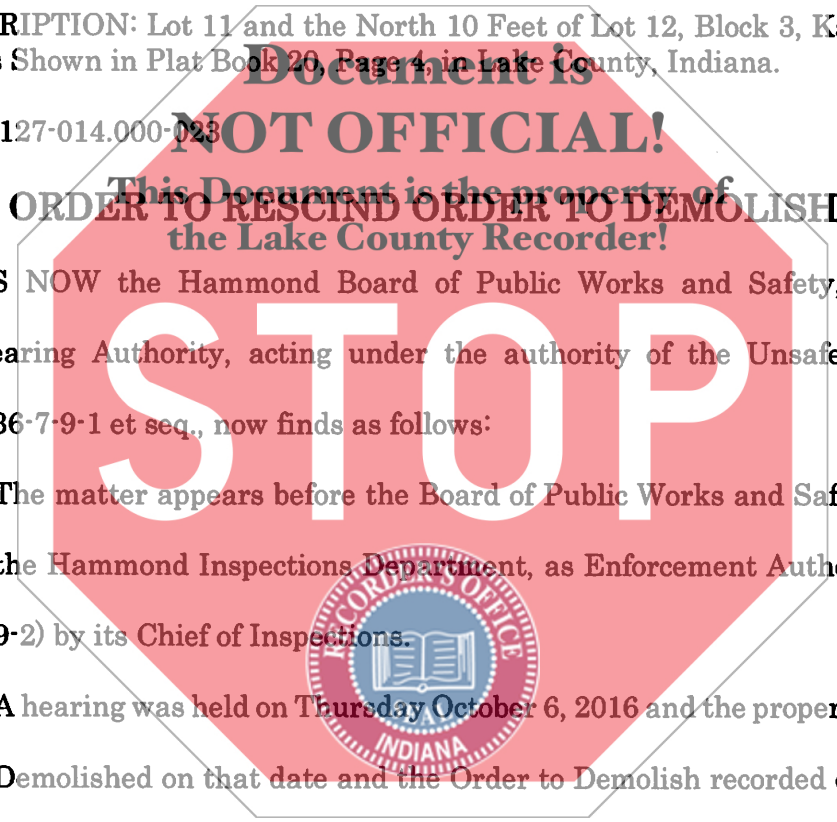

2. A hearing was held on Thursday October 6, 2016 and the property was Ordered Demolished on that date and the Order to Demolish recorded on the property on October 20, 2016 as Instrument Number 2016-070270.
3. The property has been demolished, and the Order to Demolish should be rescinded.
