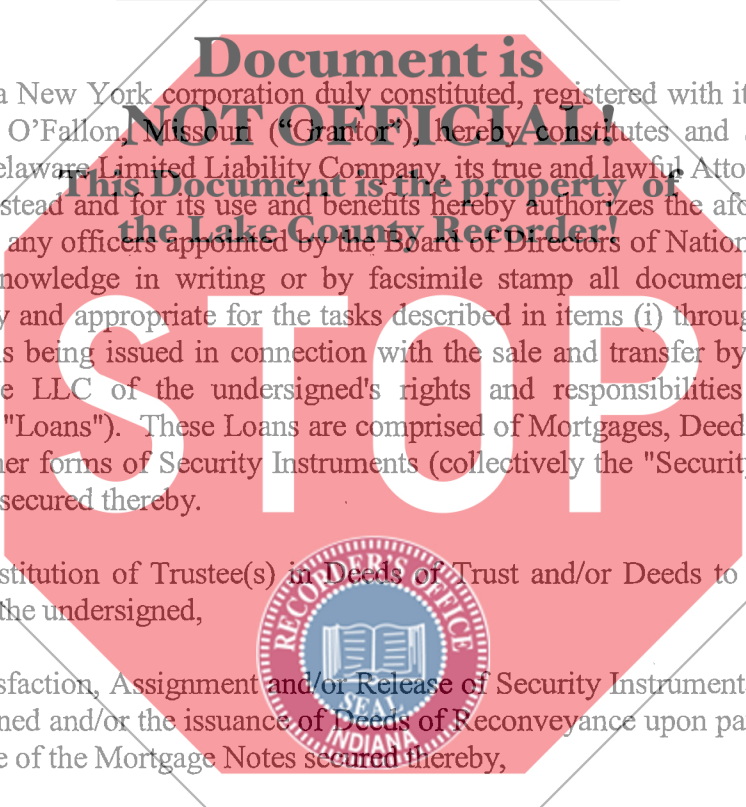

LIMITED POWER OF ATTORNEY

- (v) The endorsement on behalf of the undersigned of all checks, drafts and/or other negotiable instruments made payable to the undersigned, and
- (vi) To execute and deliver deeds of conveyance.

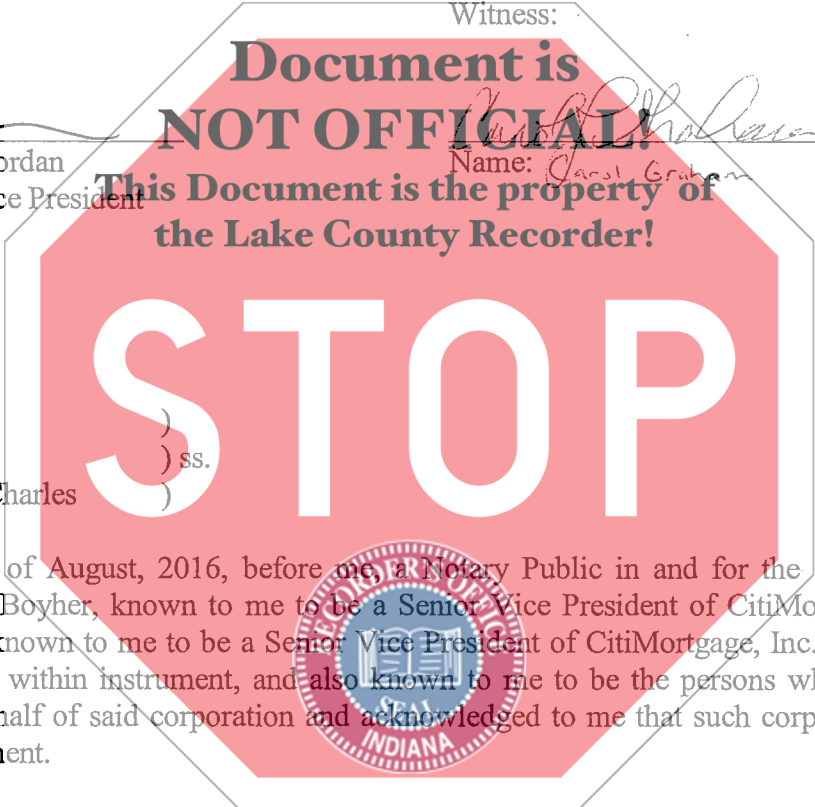
