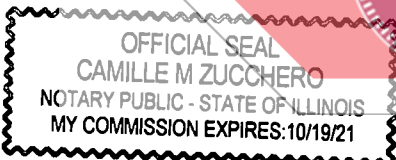

You are hereby notified that Franciscan Health Hammond, 5454 Hohman Ave., Hammond, IN 463201931, intends to hold a Hospital Lien for all reasonable and necessary charges for hospital care, treatment, or maintenance of the above-listed patient subject to the limits and reductions of any benefits to which the patient is entitled under the terms of any contract, health plan, or medical insurance.

Antonio Quintero was a patient hospitalized on 07/10/17 due to an injury that occurred on or about 07/03/17. The total charges due for hospital care, treatment, or maintenance during the above hospitalization(s) is \$1,734.00, subject to all credits for payments, contractual adjustments, write offs and any other benefit in favor of the patient. The lien is reduced from total charges to limit the patient's financial obligation under the terms of any public or private benefits to which the patient is entitled. There is no indication at this time that the patient is the beneficiary of any public or private health benefit.
