

## LIMITED POWER OF ATTORNEY

This Limited Power of Attorney is made in connection with that certain Flow Servicing Agreement (hereinafter called the "Servicing Agreement") by and between Altisource Residential, L.P., having its principal place of business at c/o Altisource Asset Management Corporation, 36C Strand Street, Christiansted, US (100820) as Initial Owner (hereinafter called "Owner") and Fay Servicing LLC (hereinafter called "Servicer") dated as of January 24, 2015.

- 2. To execute and deliver insurance filings and claims, affidavits of debt, substitutions of trustee, substitutions of counsel, non-military affidavits, notices of rescission, foreclosure deeds, transfer tax affidavits, affidavits of merit, verifications of complaints, notices to quit, bankruptcy declarations for the purpose of filing motions to lift stays, and other documents or notice filings on behalf of the Company in connection with insurance, foreclosure, bankruptcy and eviction actions.
- 3. To endorse any checks or other instruments received by Servicer and made payable to the Company;
- 4. To pursue any deficiency, debt or other obligation, secured or unsecured, including but not limited to those arising from foreclosure or other sale, promissory note or check. This


