Sealed with our seals and dated the 6th day of September, 2017.

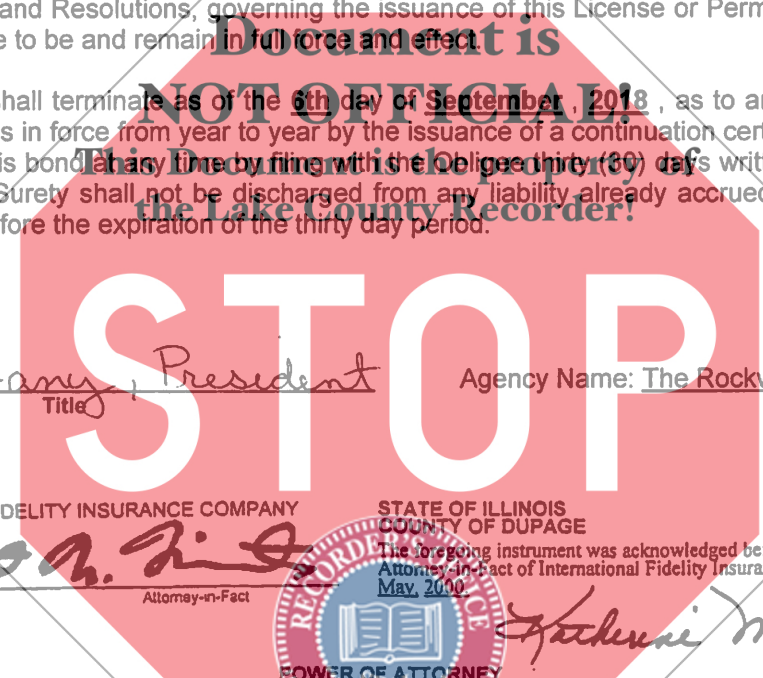

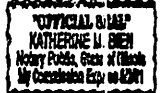
