A RESOLUTION AUTHORIZING AND APPROVING ENTRY INTO AN INTERLOCAL COOPERATION AGREEMENT WITH LAKE CENTRAL SCHOOL CORPORATION FOR A SCHOOL RESOURCE OFFICER

WHEREAS, the Town of Dyer, Lake County, Indiana, is a Municipal Corporation authorized by I. C. § 36-1-7-1, et seq., as amended from time to time, to enter into agreements with participating governmental units so as to provide better public services to the residents of the Town; and

WHEREAS, the Town Council, based upon the recommendations of the Chief of Police and Town Manager, seeks to enter into a Interlocal Cooperation Agreement based upon I. C. § 36-1-7-1, et seq., as amended from time to time, with Lake Central School Corporation, for the mutual benefit of each unit of local government; and

WHEREAS, the Town Council has determined that entry into this Interlocal Cooperation Agreement is in the best interests of the Town of Dyer, and therefore, has determined that it is advisable to enter into such Interlocal Agreement pursuant to the applicable provisions of State Law.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF TOWN OF DYER, LAKE COUNTY, INDIANA, AS FOLLOWS:

SECTION ONE: That the Town Council of the Town of Dyer, Lake Council Indiana, shall take all appropriate and legal measures to enter into a Interlocal Cooperation Agreement with Lake Central School Corporation for a School Resource Officer for the mutual benefit of the Town of Dyer and Lake Central School Corporation.

SECTION TWO: That the Town Council is hereby authorized and permitted to enter into said Interlocal Cooperation Agreement with Lake Central School Corporation, and the Town Clerk-Treasurer is hereby authorized to attest the execution of such Agreement by the Town Council.

<u>SECTION THREE:</u> That a copy of the Interlocal Cooperation Agreement between the Town of Dyer and Lake Central School Corporation shall be attached to this Resolution, and incorporated herein by reference.

SECTION FOUR: That the Town Clerk-Treasurer shall take all actions necessary and required under the provisions of I. C. § 36-1-7-1, et seq. pertaining to recordation and filing of this Resolution, with attached Agreement, upon full execution by duly authorized Officials of the Town of Dyer, Indiana, and Lake Central School Corporation, and the Town Clerk-Treasurer shall report on said recordation and filing upon completion of same.
