AFFIDAVIT OF SURVIVORSHIP

Comes now Katherine J. Henke, being duly sworn upon her oath and states as follows:

1. That Jill M. Doyle held a life estate in the following described real estate located in Lake County, Indiana, more particularly described as follows:
