or paid, the surety's total limit of liability shall not be cumulative from year to year or period to period.

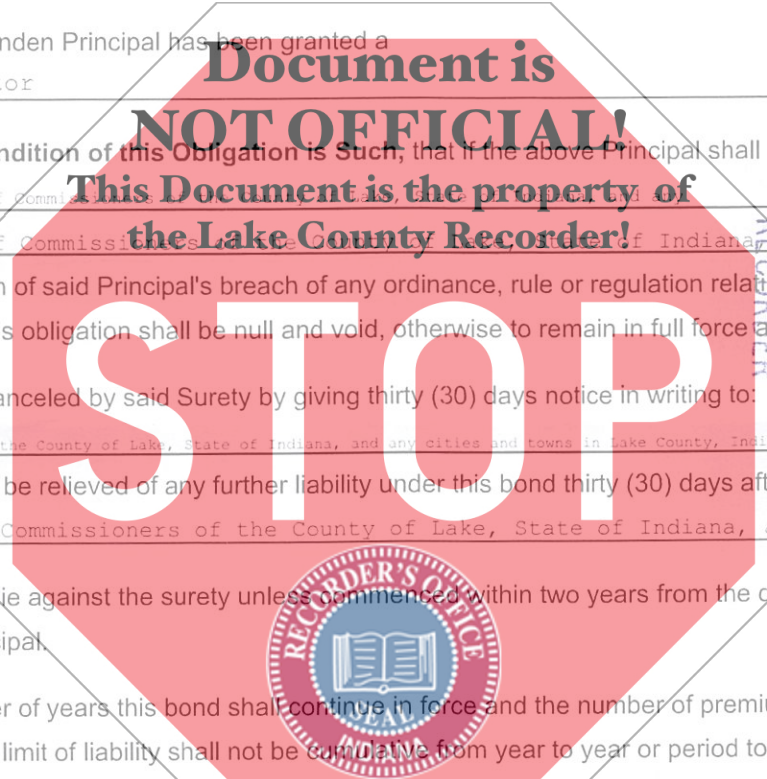

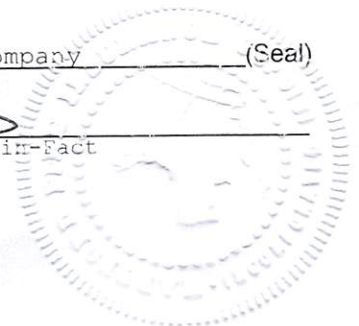
