larger amount, in the aggregate, than the penal sum listed above.

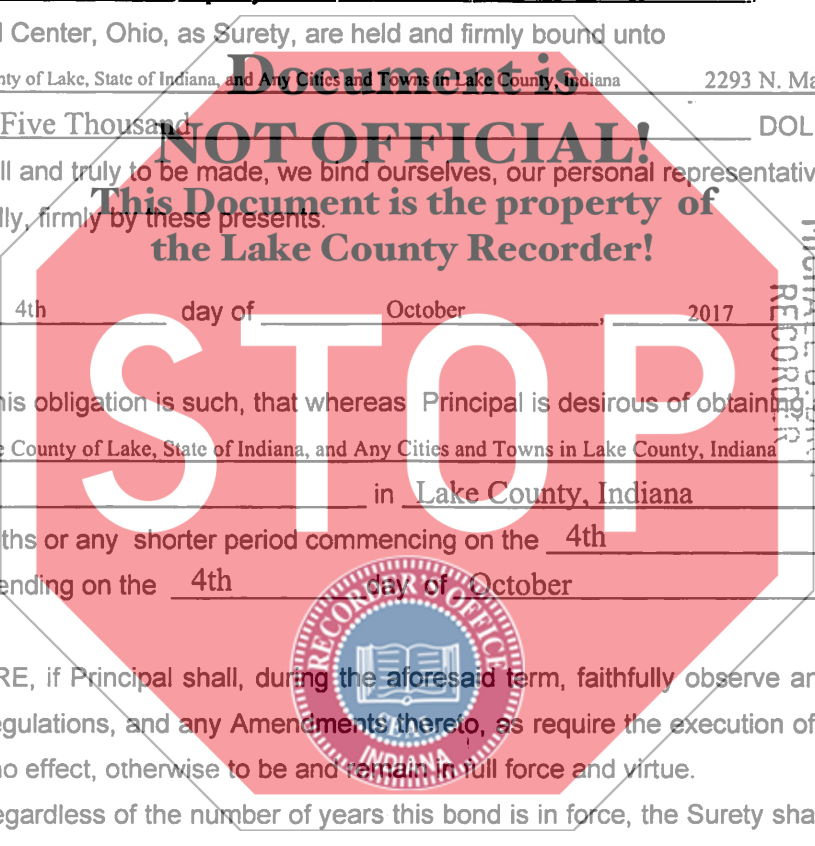
