- The Plaintiff filed this case on April 24, 2017 and a copy of the Complaint and summons was delivered to Defendant Lake County Treasurer by Sheriff on May 2, 2017, to Defendant Union Benefica Mexicana, Inc., on April 27, 2017 and Any and All Unknown Tenants were served by Publication on May 3, 10 and 17, 2017.
- 2. Defendants Lake County Treasurer has disclaimed and been dismissed as a party to this action as of September 18, 2017.

The time within which nor disclaiming Defendants were required to appear and plead has expired, and no answer, motion or other pleading, has been filed by the Defendants and a Default Judgment of said Defendants may be properly entered at this time against non-answering Defendants, or non-disclaiming Defendants, and motion for same was filed by Plaintiff;
