THE GRANTORS, Daniel W. Herald and Deborah A. Herald, Husband and Wife, of the County of Lake and State of Indiana for and in consideration of (\$10,000 Ten and 00/100 DOLLARS, and other good and valuable considerations in hand paid, Convey and (QUIT CLAIM) unto Daniel W. Herald and Deborah A. Herald, as Trustees under the provisions of a trust agreement dated the 13<sup>th</sup> day of November, 2017, and known as the Daniel W. Herald and Deborah A. Herald Joint Tenancy Trust (hereinafter referred to as "said trustee," regardless of the number of trustees,) and unto all and every successor or successors in trust under said trust agreement, the following described real estate in the County of Lake and State of Indiana, to wit:





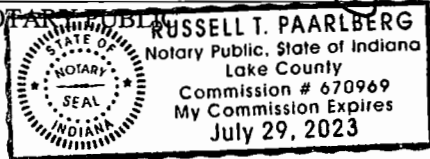
