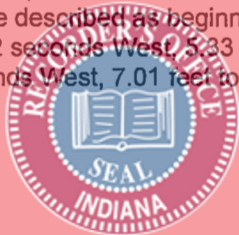

Lot 19 in Resubdivision of Part of Unit 2 of Woodmar, in the City of Hammond, as per plat thereof, recorded in Plat Book 29, page 49 in the Office of the Recorder of Lake County, Indiana, except therefrom that part deeded to the State of Indiana by Warranty Deed recorded January 10, 1992 as Document No. 92002031, described as follows: Beginning at the Southeast corner of said Lot and running thence North 89 degrees 32 minutes 06 seconds West along the South line thereof, 101.11 feet to the Southwest corner of said Lot; thence North 11 degrees 36 minutes 12 seconds West along the Westerly line of said Lot, 5.33 feet; thence North 47 degrees 18 minutes 02 seconds East, 112.19 feet; thence North 10 degrees 18 minutes 06 seconds East, 8.39 feet to the Northeasterly line of said Lot, thence South 55 degrees 00 minutes 02 seconds East, 19.57 feet along said Northeasterly line to the Northeast corner of said Lot; thence South 1 degree 35 minutes 08 seconds East along said East line 79.19 feet to the place of beginning.
